ELEVENTH AMENDMENT TO AGREEMENT NO. 33392

33392

THIS ELEVENTH AMENDMENT TO AGREEMENT NO. 33392 is made and entered, in duplicate, as of May 29, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 7, 2019, by and between THE RYTE PROFESSIONALS, a corporation ("Consultant"), with a place of business at 4141 Ball Road, #517, Cypress, California 90630, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed on an as-needed basis in connection with professional and technical services for information technology projects and systems; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33392 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the not to exceed amount to \$100,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the not to exceed amount to \$200,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to increase the not to exceed amount to \$400,000 and extend the term to January 22, 2017; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to increase the not to exceed amount to \$600,000; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to increase the not to exceed amount to \$900,000; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to increase the total not to exceed amount to \$1,500,000 and extend the term to January 22, 2018; and

WHEREAS, the Parties entered into a Seventh Amendment to the

1 Agreement to increase the total not to exceed amount to \$2,000,000; and

2 WHEREAS, the Parties entered into an Eight Amendment to the Agreement
3 to increase the total not to exceed amount to \$3,000,000 and extend the term to January
4 22, 2019; and

5 WHEREAS, the Parties entered into a Ninth Amendment to the Agreement
6 to increase the total not to exceed amount to \$3,350,000 and extend the term to May 22,
7 2019; and

8 WHEREAS, the Parties entered into a Tenth Amendment to the Agreement
9 to increase the total not to exceed amount to \$4,500,000; and

10 WHEREAS, the Parties desire to add \$500,000 to the Agreement for a total
11 not to exceed amount of \$5,000,000 and extend the term to October 22, 2019;

12 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
13 conditions herein contained, the Parties agree as follows:

14 1. Section 1.A of the Agreement is hereby amended to read as follows:

15 "A. Consultant shall furnish specialized services more particularly
16 described in Exhibit "A," attached to the Agreement and incorporated by this
17 reference, in accordance with the standards of the profession, and City shall pay
18 for these services in the manner described below, a total not to exceed contract
19 amount of Five Million Dollars (\$5,000,000), at the rates or charges shown in
20 Exhibit "A."

21 2. Section 2. of the Agreement is hereby amended to read as follows:

22 "2. TERM. The term of this Agreement shall commence on January 22,
23 2014, and shall terminate on October 22, 2019, unless sooner terminated as provided in
24 this Agreement, or unless the services or the Project is completed sooner."

25 3. Except as expressly modified herein, all of the terms and conditions
26 contained in Agreement No. 33392 are ratified and confirmed and shall remain in full force
27 and effect.
