

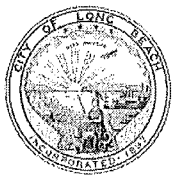

**Subject:** Stiks & Stohns ABC Application, Council Agenda Item 18

---

I am submitting the following conditions for your consideration for an original application for an On-Sale Beer and Wine license:

1. Sales, service, and consumption of alcoholic beverages shall be permitted only between the hours of 8:00 am until 11:00 pm, Sunday through Thursday, and between the hours of 8:00 am until 1:00 am, Friday through Saturday;
2. The licensee shall prevent loitering or other activity in and near the premises that could be a nuisance to adjacent uses and/or residential neighborhoods;
3. No live entertainment or dancing shall be permitted on the premises without prior permits or approval by the City of Long Beach;
4. The use of any amplified system or device is prohibited outdoors, and the use of any such system or device inside the premises shall not be audible outside the premises;
5. The licensee shall be responsible for maintaining, free of litter and graffiti, the area adjacent to the premises over which they have control. All graffiti on the premises shall be removed or covered within 24 hours of its appearance;
6. The rear doors of the premises shall be maintained closed at all times except for deliveries of merchandise and removal of trash, garbage, and other waste or recyclable material;
7. The licensee shall ensure that shipping and/or receiving activities occur only between 8:00 am and 8:00 pm;
8. The licensee shall ensure that alleys, streets, or other public areas are not used by employees and/or contractors of the licensee for equipment or utensil cleaning or other sanitary purposes.
