4 CITY OF LONG BEACH AMENDING RESOLUTION NO.
5 RES-06-0122 EXTENDING THE TIME FOR COMPLETION
6 OF UNDERGROUND UTILITY DISTRICT NO. 41 FOR
7 PORTIONS OF ALAMITOS AVENUE UNDER CALIFORNIA
8 PUBLIC UTILITIES COMMISSION RULE 20A (DISTRICTS
9 1 AND 6)

11 WHEREAS, Underground Utility District No. 41 was established following a
12 public hearing on October 17, 2006 pursuant to Resolution No. RES-06-0122; and

13 WHEREAS, it has been recommended that the time of completion for
14 Underground Utility District No. 41 be extended from December 30, 2010 to December
15 30, 2014 for completion of underground installation by utility companies and
16 reconnections, and for completion of removal of poles, overhead wires and other
17 associated overhead structures;

18 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
19 follows:

20 Section 1. The time for completion of Underground Utility District No. 41
21 shall be not later than December 30, 2014 for completion of underground installation by
22 utility companies and reconnections, and for completion of removal of poles, overhead
23 wires and other associated overhead structures.

24 Section 2. The City Clerk is hereby directed to mail a copy of this
25 resolution to all affected utilities and all persons owning real property within the district
26 within ten (10) days after adoption of this resolution.

27 Section 3. This resolution shall take effect immediately upon its adoption
28 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
