3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34987 is made and
4 entered, in duplicate, as of June 19, 2019 for reference purposes only, pursuant to
5 Resolution No. RES-18-0091 adopted by the City Council of the City of Long Beach at its
6 meeting on June 19, 2018, by and between OFFICE DEPOT, INC., a Delaware corporation
7 ("Contractor"), whose address is 3366 W. Willow Street, Signal Hill, California 90755, and
8 the CITY OF LONG BEACH ("City"), a municipal corporation.

9 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.
10 34987 (the "Agreement") whereby Contractor agreed to sell, furnish and deliver data center
11 systems equipment, telecommunications equipment, and user devices; and

12 WHEREAS, the Parties desire to extend the term one (1) additional one-year
13 period;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 1.D of the Agreement is hereby amended to read as follows:

17 "D. The term of this Agreement shall commence at midnight on June 19,
18 2018, and shall terminate at 11:59 p.m. on June 15, 2020."

19 2. Except as expressly modified herein, all of the terms and conditions
20 contained in Agreement No. 34987 are ratified and confirmed and shall remain in full force
21 and effect.
