Subject: **2021 State Legislative Agenda**

Recommendation

Respectfully request City Council approval of the 2021 State Legislative Agenda as recommended by the State Legislation Committee.

Discussion

Each year, the City Council adopts a State Legislative Agenda, which outlines the City's State legislative and funding priorities for the coming session. This document provides policy direction to staff on State issues, allowing the City to take positions on legislative proposals and to work with the City's State legislative delegates to advance priorities adopted by the City Council.

On January 5, 2021, the State Legislation Committee (Committee) met, received staff's recommended changes for the 2021 State Legislative Agenda, and voted to forward those changes, along with additional changes from the Committee, to the City Council for consideration and adoption. The full draft agenda is attached, and the Committee's proposed changes are described below:

PROPOSED LEGISLATIVE AGENDA CHANGES

Economic Development Section

Objectives

The Committee proposes to amend Objective 8 to emphasize economic inclusion, so that the item reads: "Advance economic and digital inclusion equity for residents, workers and businesses."

Focus Statements

- Support policies, legislation, and funding in alignment with the City's Climate Action and Adaptation Plan (CAAP), Los Angeles County's Community Climate Action Plan, and the State's climate change initiatives.
- Support policies, legislation, and funding to reduce air pollutants adversely impacting the environment and population's wellbeing while ensuring equitable access to healthy air quality.

Local Control Section

Objectives

The Committee proposes to include language to support the City's fiscal resiliency, which is reflected in an expanded Objective 4: "Monitor legislation related to City revenues to bolster fiscal resiliency."

Focus Statements

Related, the Committee proposes to add a Focus Statement emphasizing the need for resources and funding for the City's financial resiliency during and following the COVID-19 pandemic.

Additionally, the Committee recommends a Focus Statement to continue engagement with the State Lands Commission: "Support ongoing collaboration with the State Lands Commission and State Legislature to explore new funding sources to support City priorities."

City Council Directives

The Committee has no proposed changes.

COVID-19 Advocacy Strategy

The Committee proposes to emphasize economic recovery. Language will be added to the "Relief Funding Priorities" section to underscore the need for resources to implement the City's Economic Recovery Strategy, upon approval of the City Council, and to support the City's fiscal resiliency through investments in new and resilient industries for job creation and opportunities to lift families out of poverty.

Subject: **2021 Draft State Legislative Agenda**

Each year, City staff reviews the State Legislative Agenda and recommends changes to ensure the agenda reflects and advocates for the legislative and funding priorities of the City of Long Beach (City). In October 2020, the adopted 2020 State Legislative Agenda was sent to all departments for input to incorporate into the 2021 Draft State Legislative Agenda, and the Government Affairs team met with departments to understand their recommended legislative and funding priorities for the upcoming year.

Attachment A (“2021 Draft State Legislative Agenda”) incorporates staff recommendations for the State Legislation Committee’s consideration. New language is indicated by blue underlined text; moved or streamlined language is indicated by green underlined text; and deleted language is indicated by ~~red-strikethrough~~ text. Next to added or revised language is the name of the department in parentheses pertaining to that specific recommended revision, indicated by highlighted text.

Given the unprecedented impacts of COVID-19 on the City’s legislative and funding priorities, Attachment B (“COVID-19 Advocacy Strategy”) outlines a proposed strategy for the City to advocate for resources and needs specific to the pandemic, based on City Council action over the past year and departmental priorities. While some specific items related to COVID-19 response are also incorporated in the draft legislative agenda, the urgency and scope of the pandemic necessitate a targeted advocacy strategy and one-pager that can be easily shared with the delegation.

Proposed Changes to the State Legislative Agenda

This memorandum explains the rationale behind staff’s recommendations for significant revisions to the 2021 Draft State Legislative Agenda. Explanations of the revisions are organized by topic, and many are shared with the proposed 2021 Federal Legislative Agenda. Please refer to Attachment A for the specific proposed language.

ECONOMIC DEVELOPMENT

Over the past year, the COVID-19 pandemic devastated local businesses and industry sectors. Staff recommend incorporating a 2021 Focus Statement to support legislation and resources that will help to mitigate the financial impacts of the pandemic on businesses, workers, and community members.

Under Objective 1, staff recommend adding export clusters to existing Item J. Staff also recommend moving Item K related to crypto currency and bitcoin regulation that was previously in the Public Safety section, since it is more directly related to Economic Development.

Staff recommend minor changes in Objectives 4 and 5. Staff recommend deleting Item 4K, due to duplication with Item 4J. The Harbor Department also recommends moving Item 5F to the Federal Legislative Agenda, since resources for dredging are more of federal importance. They further recommend clarifying language for Item 5G regarding the development of zero-emission and near-zero emission technology and infrastructure at the port.

Staff propose adding an item to Objective 6 related to the City's COVID-19 economic relief package for working families and small businesses, passed by Council on March 17, 2020.

The pandemic has also underscored the need for digital resources and the disparate impacts arising from the digital divide. Staff recommend adding Objective 8 to advance digital inclusion and equity for residents, workers, and businesses. The objective includes new directives for legislative and funding advocacy based on the City's Digital Inclusion Initiative and ongoing CARES Act programs related to digital inclusion, in addition to expanding broadband infrastructure and consumer privacy protections. Staff recommend Item J to expand resources and funding for Cybersecurity systems to protect City infrastructure. Item K is proposed based on a recommended action within the Racial Equity and Reconciliation – Initial Report related to funding digital inclusion efforts.

PUBLIC SAFETY

Following the death of George Floyd in Minneapolis, Minnesota, the topic of community safety and racial equity has been a top priority for the City and for state and federal legislators. On June 24, 2020, the State Legislation Committee voted unanimously to request staff to revisit the Public Safety section of the agenda. The Committee's priorities for the agenda included expanding items related to:

- Transparency and accountability;
- Alternative models to community policing, engagement, and maintaining public trust;
- Training—to improve standards related to responding to domestic violence calls, tolerance, and equity;
- The role of civilian oversight; and,
- Increasing mental health resources for police officers.

Furthermore, on August 11, 2020, the City Council unanimously approved the Racial Equity and Reconciliation Initiative – Initial Report (Report), which includes policy priorities to advance racial equity. As part of the Reconciliation implementation plan, staff are leading a policy workgroup to develop a draft equity policy advocacy strategy for Committee and Council consideration.

Staff recommendations for the 2021 Draft State Legislative Agenda seek to capture the Committee's priorities and the items outlined in the Report. Upon review, staff recognized that many of the existing directives in the Public Safety section of the agenda did not align with their respective objectives. Many of the recommended staff changes are to move and streamline language that was in the formerly adopted agenda. Staff also recommend incorporating new items based on the Committee's input and the Report related to racial equity.

For the 2021 Focus Statements, staff recommend removing the item related to realignment-related public safety operations and instead adding a statement to support implementation of the Safe Long Beach Violence Prevention Plan, in alignment with the Federal Legislative Agenda. Staff also recommend slightly amending the last statement to reflect the priority for collaboration between public safety and health.

Objective 1 includes several proposed new items, in addition to moving existing items. The new items pertain to gun violence, including enhanced regulation of "ghost guns" which are weapons assembled from the acquisition of legal weapon components; data management; broadening the definition and sentencing of hate crimes; funding for training and evaluating use of force policies; and enhancing penalties for false reporting based on racial bias.

Objective 2 includes a number of items that were moved to better align with other objectives. Item B related to expanding statewide restrictions on fireworks, penalties, and oversight is recommended based on Council action taken on June 23, 2020. Staff also recommend a new item to expand resources for re-entry programming and services based on Goal 2 of the Reconciliation Report.

In Objective 3, staff recommend moving and streamlining several existing items. Staff also propose five new recommendations. Items F and P are based on the Reconciliation Report relating to violence prevention and intervention models. Items I, J, and K are related to the State Legislation Committee's recommendations to support resources for multi-agency collaboration and partnerships in public safety and health; mental health resources for peace offices; and funding for implicit and racial bias training, de-escalation, and alternatives to deadly force.

Objective 4 also includes five new proposed items to advance accountability and transparency. Items G, H, and I relate to supporting resources and policies to track information related to public safety officers that resign in lieu of discipline or termination due to violations, the advancement of decertification standards, and funding to support public disclosure of files related to misconduct. Item J is recommended to expand funding and resources for education programs in criminal justice. Finally, Item K is based on Goal 3 the Reconciliation Report, advocating for the City's participation in several public safety reform initiatives.

Given the importance of the pandemic for legislative and funding advocacy, staff also recommend a new Objective 5 focused on response to emergencies. Most of the items were already in the previously adopted agenda and have been moved to align with this objective, while Item F is new based on the City's priority to advance equitable and inclusive emergency

response.

PUBLIC HEALTH

The COVID-19 pandemic has demonstrated the importance of public health to nearly all aspects of the City's legislative agendas. As one of three cities in the State with a municipally operated health department, advocating for policies and funding for the City's public health efforts is a priority. Therefore, staff recommend creating a new Public Health section to the 2021 Draft State Legislative Agenda.

Many of this section's proposed objectives and directives have been moved and revised from Sustainable & Livable Cities section. Objective 1 includes items pertaining to the Health Department's prevention, management, and recovery programs and services. The COVID-19 pandemic has demonstrated funding challenges for the City's public health efforts, so staff have proposed to address the need for more resources and support related to public health functions, research, and response. Items B, C, G, H, and I support funding allocations from the State to our local health jurisdiction for various public health programs and needs. Staff recommend Items W and X to improve data-driven public health initiatives for underserved communities and to advance public health priorities outlined in the Reconciliation Report.

Similarly, Objectives 2 and 3 contain mostly items that were previously adopted in the agenda, with a few new items. Objective 2 focuses on outdoor infrastructure and programs pertaining to physical health with proposed Item 2G regarding safe rights-of-way and injury prevention. Objective 3 focuses on the impacts of cannabis and tobacco products with new Items 3F and 3G regarding efforts to advance health related to e-cigarettes and second-hand smoke.

Objective 4 is a proposed new objective to streamline existing items and add one new item regarding the City's homeless services efforts. Objective 4 aggregates items about the recommendations within the Everyone Home Long Beach Report. Addressing the statewide homeless crisis remains a City advocacy priority for 2021.

EDUCATION

Staff propose minimal changes. Staff propose a new item in Objective 1 to recognize educational resources for older adults and additions to items in Objective 2 and Objective 4 related to near-zero and zero-emission technology training and educational programs to increase the quality of life for Long Beach residents. Staff recommend adding Item 2H based on Goal 1 of the Reconciliation Report to connect students of color with pathways to City employment.

SUSTAINABLE AND LIVABLE CITIES

The State Legislature has introduced several legislative proposals in the past few years regarding modes of active transportation and transit-oriented development, reflected in Objective 3. Staff recommend adding new items to support local priorities regarding mobility

technology, active transportation infrastructure, and coordination with the State on State right-of-way. Moreover, Public Works staff recommend adding Objective 4 with new proposed items to support improvements to roadway safety through local traffic enforcement mechanisms, complete streets priorities, and incentives for safer forms of transportation.

Under Objective 5 regarding support for the City's affordable housing policies and adopted Housing Element, staff recommend adding new items related to the inclusion of Internet service among essential utilities covered by housing vouchers. Development Services also recommends supporting policies and funding for the development of moderate-income housing and homeownership programs, and legislation for reasonable requirements on the development of single-family homes into multi-unit housing. Additionally, staff recommend adding Items M and N based on Council action to support eviction and foreclosure protections for residents and businesses during emergencies. Staff recommend Item N to support funding opportunities for the City's Universal Basic Income pilot program. Finally, Item O is proposed based on the Reconciliation Report to advance affordable and supportive housing opportunities for the reentry population.

Under Objective 6, the Harbor Department recommends adding language to support cap and trade credits for the port's Clean Air Action Plan and proposals that advance renewable energy and energy efficiency at the port.

Lastly, staff recommend deleting items in the final three Objectives related to public health, in order to move them to the new proposed Public Health section. Instead, existing items related to the City's Animal Care Services have been moved to a new Objective 7, to better align with the section.

LOCAL CONTROL

Staff recommend moving language related to the City's Safe Long Beach and My Brother's Keeper programs to the Public Health section. In addition, following the completion of the 2020 Census count, 2021 redistricting efforts are underway. Staff propose adding items 1Z and 1AA pertaining to equitable redrawing of district boundaries and retaining the vast majority of Long Beach in predominant seats for state representatives, as was achieved in the 2010 redistricting process.

COVID-19 Advocacy Priorities

In addition to the proposed changes to the legislative agenda, staff recommend a stand-alone document that outlines the City's priorities related to legislative and funding advocacy for COVID-19 response. The pandemic has impacted the city and community in myriad ways; and defining a core set of priorities will bolster the City's advocacy efforts. Attachment B, therefore, proposes some of the core needs for the City's response to the pandemic, including local funding for economic recovery, public health resources, infrastructure stimulus, and community supports.

Next Steps

A State Legislation Committee meeting will be scheduled in January 2021 to review and discuss staff's recommended changes to the 2021 State Legislative Agenda. Upon approval by the State Legislation Committee, the Committee will forward the proposed agenda to the full City Council for consideration and adoption. About Long Beach

Incorporated in 1888, Long Beach, California is a progressive urban city made up of 464,000 residents and businesses. The City is home to the 2nd busiest port in the nation, a rejuvenated downtown, tourist attractions, one unified school district, a city college with two campuses, a state university, over 60 residential neighborhoods, 18 historical districts, and over 180 local neighborhoods and business organizations.

Long Beach is the 7th largest city in California, and the 2nd largest in Los Angeles County. The U.S. Census (2010) found that the median age in Long Beach is 33 years old, and 25% of the City's residents are under the age of 18.

The City is ethnically diverse with: 40.8% Latino/Hispanic, 29.4% Caucasian, 13.0% African American, 12.6% Asian, and 1.1% Native Hawaiian and other Pacific Islander.

The Los Angeles-Long Beach-Santa Ana area ranked #2 in the nation for having the greatest number of Lesbian, Gay, Bisexual or Transgender (LGBT) persons. Long Beach has consistently been one of the only cities nationwide to achieve a perfect score on the Human Rights Campaign's Municipal Equality Index.

Long Beach Unified School District has 82,000 students spread over 84 schools. There are five charter schools and more than 40 private schools in Long Beach. Across the school district, 80% of high school students graduate on time. Long Beach City College and the California State University, Long Beach serve as local education hubs.

The City's economy is expanding as the region's economic base continues to shift from manufacturing to an information-based economy. There are several hundred businesses in the City. The top 10 private sector employers include Verizon and Boeing. The Port of Long Beach remains the port of choice, with innovative transportation solutions, infrastructure improvements, environmental mitigation and community engagement programs.

The Port of Long Beach is undertaking multiple programs to enhance competitiveness and environmental sustainability. Over the next 10 years, the Port will invest more than \$1.7 billion in capital improvements, including \$1 billion in projects that will expand on-dock rail use and minimize cargo truck trips on local roads and freeways. The Port is currently engaged in \$150 million worth of projects to demonstrate the effectiveness of zero-emissions cargo-handling and power-storage equipment. (Harbor Department)

Groundbreaking new programs and technologies are used in Long Beach to provide city services. The Long Beach Police Department has assembled the LB COP system using grant funds to integrate technologies to make this City a safer place to do business, live, work and play. The Long Beach Public Library has 12 branches with over 1.2 million visitors and 1.3 million materials loaned annually, and the City's Parks, Recreation and Marine Department has won the National Gold Medal Award 5 years in a row for providing quality programming and open space at over 170 locations throughout Long Beach.

- i) Support legislation to reduce blight in neighborhoods by placing reasonable restrictions on utilizing vehicles solely for the purpose of advertisement.
- j) Support policies and legislation that would grant discretion to local government Traffic Engineers to make the final determination of a safe and reasonable speed limit.
- k) Oppose policies and legislation that restrict the use of local housing funds.
- l) Support or sponsor legislation to extend the authority of the Long Beach Oversight Board of the City of Long Beach as the Successor Agency to the Redevelopment Agency of the City of Long Beach.
- m) Oppose the regionalization of airports as it relates to the allocation of flights and the loss of local authority.

Draft COVID-19 Advocacy Strategy

The City of Long Beach supports advocating for the following priorities related to COVID-19 pandemic response legislation, funding, and resources:

- **State and Local Funding**
 - Direct Allocations
 - Allocate funds directly to the City and/or local health jurisdictions
 - Eliminate or reduce the 500,000-population minimum threshold to receive direct City allocations
 - Timeline and Flexibility
 - Expanded timeline or no deadline to expend funds
 - Allow funding to be eligible for responding to, mitigating, covering costs, and replacing foregone revenues as a result of the pandemic
- **Relief Funding Priorities**
 - The City prioritizes the following uses for direct federal relief funding, in line with the City Council-approved CARES Act spending plan:
 - COVID-19 emergency and public health response expenditures
 - Revenue loss backfill (if eligible)—allowing the City to provide economic relief not permitted under CARES Act funding, including City fee reductions and waivers
 - Economic recovery: small business relief; digital inclusion resources and services; and support for hardest-hit sectors like nonprofits, restaurants, bars, and artists
 - Community support: homeless sheltering and services; food security; mental health resources; and public health services for the hardest-hit communities including Black residents, communities of color, older adults, and working families
- **State and Federal Public Health Resources**
 - A national testing and contact tracing initiative
 - Funding to support local testing and public health infrastructure
 - Funding for local vaccine storage and distribution
 - Increased Medicaid funding and benefit programs such as SNAP
- **State and Federal Community Resources**
 - Direct stimulus payments to residents
 - Expanded and extended unemployment insurance payments
 - Business relief resources, including a restaurant revitalization fund
 - Housing resources, including additional CDBG, HOME, and ESG funds, emergency rental assistance, foreclosure and evictions protections, and mortgage forbearance
 - Suspend State and Local income tax deduction cap and expand eligibility for Earned Income Tax Credit
- **Critical Infrastructure Investments**
 - Stimulus should include investments in infrastructure projects that have been delayed and otherwise impacted by the pandemic, such as City facility improvements, street and sidewalk rehabilitation, park projects, fiber connectivity and broadband infrastructure, and critical transportation improvements.
