1 FIRST AMENDMENT TO AGREEMENT NO. 35395

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35395 is made and
4 entered, in duplicate, as of June 24, 2020 for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on August 20,
6 2019, by and between GHD INC., a California corporation ("Consultant"), with a place of
7 business at 320 Goddard Way, Suite 200, Irvine, California 92618, and the CITY OF LONG
8 BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 35395 (the "Agreement") whereby Consultant agreed to provide as-needed, on-call
11 consulting services for street design projects; and

12 WHEREAS, the Parties desire to add \$3,000,000 to the Agreement for a total
13 not to exceed amount of \$4,000,000;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 1.A. of the Agreement is hereby amended to read as follows:

17 "A. Consultant shall furnish specialized services more particularly
18 described in Exhibit "A", attached to this Agreement and incorporated by this
19 reference, in accordance with the standards of the profession, and City shall pay for
20 these services in the manner described below, in an amount not to exceed Four
21 Million Dollars (\$4,000,000), at the rates or charges shown in Exhibit "B".

22 2. Except as expressly modified herein, all of the terms and conditions
23 contained in Agreement No. 35395 are ratified and confirmed and shall remain in full force
24 and effect.
