

1 FIRST AMENDMENT TO AGREEMENT NO. 34362

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34362 is made and
4 entered, in duplicate, as of June 19, 2019, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on August
6 2, 2016, by and between GRIFFIN STRUCTURES, INC., a California corporation
7 ("Consultant"), with a place of business at 2 Technology Drive, Suite 150, Irvine, California
8 92618, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 34362 (the "Agreement") whereby Consultant agreed to provide as-needed public works
11 construction management and inspection services; and

12 WHEREAS, the Parties desire to extend the term one (1) additional one-year
13 period;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 2 of the Agreement is hereby amended to read as follows:

17 "2. TERM. The term of this Agreement shall commence at midnight on
18 August 31, 2016, and shall terminate at 11:59 p.m. on August 31, 2020, unless sooner
19 terminated as provided in this Agreement, or unless the services or the Project is
20 completed sooner. The term may be extended for one (1) additional one-year period, at
21 the discretion of the City Manager."

22 2. Except as expressly amended herein, all terms and conditions in
23 Agreement No. 34362 are ratified and confirmed and shall remain in full force and effect.


