SECOND AMENDMENT TO CONTRACT NO. 34730

THIS SECOND AMENDMENT TO CONTRACT NO. 34730 is entered into, in duplicate, effective as of December 24, 2018, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on July 18, 2017, by and between PERFORMANCE EXCELLENCE PARTNERS, LLC, a Delaware limited liability company ("Contractor"), with offices located at 7911 Professional Circle, Huntington Beach, California 92648, and the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for Pacific Gateway Workforce Investment Network.

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 34730 whereby Contractor agreed to provide various workforce development services to Pacific Gateway and its Board; and

WHEREAS, the Parties entered into a First Amendment to Contract No. 34730 to add \$60,000 for a total not to exceed amount of \$250,000; and

WHEREAS, the Parties desire to add \$160,000 to Contract No. 34730 for a total not to exceed amount of \$410,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 5.A of the Contract is hereby amended to read as follows:

"A. The total amount which shall be payable by City to Contractor for Contractor's allowable services during the Term shall not exceed Four Hundred Ten Thousand Dollars (\$410,000)."

2. Except as expressly amended herein, all terms and conditions in Contract No. 34730 are ratified and confirmed and shall remain in full force and effect.
