In accordance with procedures for changes in the work as established in the specifications, you are authorized to do the following:

- PCO 011.1 Sprint Structural Revisions: per Bulletin 005.2 provide all labor, materials, equipment, transportation and incidentals to add additional structural components as indicated to accommodate changes to the Sprint equipment at the roof level. A portion of this PCO not pertaining to this scope has been paid under separate cover. The Contractor shall provide this work as directed by the City Engineer on a lump sum basis, for the cost of......\$ 1,298.23
- PCO 015.5 Sprint Electrical Revisions: per Bulletin 005.1 and 005.3 provide all labor, materials, equipment, transportation and incidentals to add additional electrical scope for generator plug and pathway to rooftop equipment by others. This scope shall be inclusive of all itemized line items on COR 15.5 provided by the Contractor. The Contractor shall provide this work as directed by the City Engineer on a lump sum basis, for the cost of ......\$ 10,342.71

By signing this change order the Contractor acknowledges that it is familiar with California Civil Code Section 1542, which reads: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor;" and Contractor hereby releases the City from any unknown claims and waives its rights under Section 1542.
