RESOLUTION NO. RES-17-0122

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE THREE CNG-POWERED STREET SWEEPERS, WITH RELATED EQUIPMENT AND ACCESSORIES THROUGH THE CONTRACT BETWEEN NATIONAL JOINT POWERS ALLIANCE AND HAAKER EQUIPMENT COMPANY

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase three (3) CNG-powered Street Sweepers, with related equipment and accessories ("Street Sweepers"); and

WHEREAS, the National Joint Powers Alliance has a Contract for the purchase of these Street Sweepers, Contract No. 022014-FSC (" NJPA Contract"); and

WHEREAS, the City's participation in the NJPA Contract will facilitate acquisition of these Street Sweepers as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the NJPA Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The City Manager or designee of the City is hereby authorized

1 to enter an agreement with Haaker Equipment Company to purchase three (3) CNG-  
2 powered Street Sweepers, with related equipment and accessories of substantially the  
3 same type and kind purchased by the National Joint Powers Alliance pursuant to the  
4 Contract No. 022014-FSC except as modified by mutual agreement of the City and  
5 Haaker Equipment Company, and the purchase by the City shall be on the same terms  
6 and conditions afforded to the National Joint Powers Alliance in an amount not to exceed  
7 Nine Hundred Seventy Four Thousand Eight Hundred Five Dollars (\$974,805) including  
8 tax and fees.

9 Section 3. This resolution shall take effect immediately upon its adoption  
10 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
