

1 FIFTH AMENDMENT TO AGREEMENT NO. 33427

3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 33427 is made and
4 entered, in duplicate, as of December 16, 2020, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 August 14, 2018, by and between CELLCO PARTNERSHIP DBA VERIZON WIRELESS
7 ("Verizon"), located at 15505 Sand Canyon Avenue, Bldg. E102, Irvine, California 92618
8 and the CITY OF LONG BEACH, a municipal corporation ("Client" or "City").

9 WHEREAS, City and Verizon (the "Parties") entered into Agreement No.
10 33427 (the "Agreement") whereby Verizon agreed to provide cellular phone and data
11 services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to
13 increase the annual not to exceed amount to \$330,000; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement
15 to increase the annual not to exceed amount to \$400,000; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement
17 to extend the term to June 30, 2020; and

18 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
19 to extend the term to December 31, 2020; and

20 WHEREAS, the State of California Contract No. 7-10-70-15 was extended,
21 therefore, the Parties desire to extend the term of the Agreement;

22 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
23 conditions herein contained, the Parties agree as follows:

24 1. Section 2 of the Agreement is hereby amended to read as follows:

25 "2. TERM. The term of this Agreement shall commence on April 1, 2014,
26 and shall terminate at 11:59 p.m. on March 31, 2021. This Agreement may be terminated
27 by Client for cause or convenience on thirty (30) days prior notice without penalty or further
28 obligation after Client has paid for services rendered through the date of termination.
