FIRST AMENDMENT
TO AGREEMENT NUMBER C-122203 OF CITY OF LOS ANGELES CONTRACT

THIS FIRST AMENDMENT to Agreement Number C-122203 of City of Los Angeles Contract is made and entered into by and between the City of Los Angeles ("City") and City of Long Beach (Administering Entity for Pacific Gateway Workforce Investment Network) ("Contractor"), a Governmental Agency.

RECITALS

WHEREAS, the City and Contractor have entered into an Agreement wherein Contractor shall provide certain services. Said Agreement was effective March 1, 2013, which together with all amendment(s) thereto shall hereinafter be referred to as the Agreement; and

WHEREAS, PSC-6, Exhibit A, Standard Provisions for City Contracts, provides for amendments to the Agreement; and

WHEREAS, the Agreement contemplates that modifications and closeout activities may be required after the time set forth in Section 201 of the Agreement; and

WHEREAS, the City and Contractor are desirous of amending the Agreement as authorized by the City Council and the Mayor (refer to Council File Number 13-0728 dated June 27, 2013), which authorizes the General Manager of the Community Development Department, or its successor entity, to prepare and execute an amendment to the Agreement for the purpose of:

- (a) adding an additional Nine (9) months for a new ending date of March 31, 2014;
- (b) adding additional services to the Agreement;
- (c) adding additional funds in the amount of Forty Three Thousand Dollars (\$43,000) for a new total of Two Hundred Ninety Three Thousand Dollars (\$293,000); and
- (d) making such other changes as are required in connection with the foregoing, all as detailed elsewhere in this Amendment; and

WHEREAS, this Amendment is necessary and proper to continue and/or complete certain activities authorized under the Agreement.

NOW, THEREFORE, the City and Contractor agree that the Agreement be amended effective July 1, 2013 as follows:

AMENDMENT

- §1. Amend Section 201 of the original Agreement, Time of Performance, by deleting the current ending date of June 30, 2013 and replacing with the new ending date of March 31, 2014. This amendment adds an additional Nine (9) months to the Agreement for a total term of Thirteen (13) months.
- §2. Amend the fifth (no.5) performance measure, New Enrolled Customers, of Performance Measures and Service Levels Table in Section B.3. of Exhibit I of the original Agreement, Scope of Work and Contractor Responsibility, by deleting the row and replacing with the following:

- §3. Amend Section 301A of the original Agreement, Compensation, by deleting the current total dollar amount of Two Hundred Fifty Thousand Dollars (\$250,000) and replacing with a new total dollar amount of Two Hundred Ninety Three Thousand Dollars (\$293,000).

This amendment adds an additional Forty Three Thousand Dollars (\$43,000) for a new total of Two Hundred Ninety Three Thousand Dollars (\$293,000). Funding allocation for the full term of this Agreement shall be as follows:

- §5. This Amendment is executed in two (2) duplicate originals, each of which is deemed to be an original. This Amendment includes Three (3) pages which constitute the entire understanding and agreement of the parties.
