## FOURTH AMENDMENT TO AGREEMENT NO. 35050

THIS FOURTH AMENDMENT TO AGREEMENT NO. 35050 is made and entered, in duplicate, as of October 1, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 4, 2018, by and between GALVIN PRESERVATION ASSOCIATES INC., a California corporation ("Consultant"), with a place of business at 201 Nevada Street, Suite B, El Segundo, California 90245, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35050 (the "Agreement") whereby Consultant agreed to provide on-call historic preservation consultant services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$35,000 for a total not to exceed amount of \$160,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$40,000 for a total not to exceed amount of \$200,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to September 30, 2021; and

WHEREAS, the Parties desire to add \$80,000 to the Agreement for a total not to exceed amount of \$280,000 and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Hundred Eighty Thousand Dollars (\$280,000), at the rates or charges shown in Exhibit "B"."
