- 1.1 Change order required to transfer unused equipment from contractor to the City. Equipment was purchased by the contractor for this project per plan and removed from scope during construction.
- 1.2 Change order required to remove and replace pushbutton poles at Long Beach/27th NE corner and Long Beach/5th median to meet ADA standards.

- 2.1 Provide all labor, material and equipment for delivery of unused equipment to Traffic Operations. Equipment is as follows: 4 ea # 6 pullboxes, 10 ea #6e pullboxes, 3 ea 333L control cabinets, 5 ea GPS time source units, 10 ea surge protectors.
- 2.2 Provide all labor, material and equipment to remove noncompliant ADA pushbutton poles and replace with ADA compliant pushbutton poles for new APS pushbuttons at Long Beach/27th and Long Beach/5th.
