1 FOURTH AMENDMENT TO AGREEMENT NO. 31922

3 THIS FOURTH AMENDMENT TO AGREEMENT NO. 31922 is made and
4 entered, in duplicate, as of December 17, 2014 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 December 16, 2014, by and between GHD INC. (formerly known as WINZLER &
7 KELLY), a California corporation, with a place of business at 16451 Scientific Way, Irvine,
8 California 92618 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, the City requires specialized services requiring unique skills to
11 be performed in connection with As-Needed Engineering Consulting Services; and

12 WHEREAS, the parties entered Agreement No. 31922 whereby Consultant
13 agreed to provide As-Needed Engineering Consulting Services; and

14 WHEREAS, the parties desire to extend the term and increase the
15 Agreement amount by \$500,000 for a total not to exceed amount of \$1,375,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions herein contained, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 31922 is hereby amended to read as
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, not to exceed One Million Three
25 Hundred Seventy-Five Thousand Dollars (\$1,375,000), at the rates or charges
26 shown in Exhibit "B".

27 2. Section 2 of Agreement No. 31922 is hereby amended to read as
28 follows:

1 "2. TERM. The term of this Agreement shall commence at midnight on
2 September 15, 2010, and shall terminate at 11:59 p.m. on December 30, 2015, unless
3 sooner terminated as provided in this Agreement, or unless the services or the Project is
4 completed sooner."

5 3. Except as expressly modified herein, all of the terms and conditions
6 contained in Agreement No. 31922 are ratified and confirmed and shall remain in full
7 force and effect.

9 executed with all formalities required by law as of the date first stated above.
