1 FIRST AMENDMENT TO AGREEMENT NO. 34940

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34940 is made and

4 entered, in duplicate, as of May 18, 2021, for reference purposes only, pursuant to a minute  
5 order adopted by the City Council of the City of Long Beach at its meeting on April 17,  
6 2018, by and ELITE LINE SERVICES, INC., a Florida corporation ("Contractor"), with a  
7 place of business at 1505 Luna Road, Suite 100, Carrollton, Texas 75006, and the CITY  
8 OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.  
10 34940 (the "Agreement") whereby Contractor agreed to provide baggage handling system  
11 maintenance at the Long Beach Airport; and

12 WHEREAS, the Parties desire to extend the term one (1) additional one-year  
13 period and add \$1,039,638 to the extension;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
15 conditions herein contained, the Parties agree as follows:

16 1. Section 1.A. of the Agreement is hereby amended to read as follows:

17 "A. Contractor shall furnish specialized services more particularly  
18 described in Request for Proposals (RFP) AP18-035, attached to the Agreement as  
19 Exhibit "A" and incorporated by this reference, in accordance with the standards of  
20 the profession, and City shall pay for these services in the manner described below,  
21 not to exceed Three Million Eighteen Thousand Two Hundred Ninety-Three Dollars  
22 (\$3,018,293) for the term June 1, 2018 through May 31, 2021, and One Million  
23 Thirty-Nine Thousand Six Hundred Thirty-Eight Dollars (\$1,039,638) for the term  
24 June 1, 2021 through May 31, 2022, at the rates or charges shown in Exhibit "B"."

25 2. Section 2 of the Agreement is hereby amended to read as follows:

26 "2. TERM. The term of this Agreement shall commence at midnight on  
27 June 1, 2018, and shall terminate at 11:59 p.m. on May 31, 2022, unless sooner terminated  
28 as provided in this Agreement, or unless the services or the Project is completed sooner."

1 3. Except as expressly amended herein, all terms and conditions in  
2 Agreement No. 34940 are ratified and confirmed and shall remain in full force and effect.
