

RESOLUTION NO. RES-23-0116

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT WITH L.N. CURTIS & SONS, OF WALNUT CREEK, CA TO FURNISH AND DELIVER EMERGENCY RESPONSE AND FIREFIGHTING EQUIPMENT, ON THE SAME TERMS AND CONDITIONS AFFORDED TO SOURCEWELL IN AN ANNUAL AMOUNT NOT TO EXCEED \$200,000, UNTIL THE SOURCEWELL CONTRACT EXPIRES ON MAY 7, 2024, WITH THE OPTION TO RENEW FOR AS LONG AS THE SOURCEWELL CONTRACT IS IN EFFECT, AT THE DISCRETION OF THE CITY MANAGER

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to furnish and deliver emergency response and firefighting equipment, and L.N. Curtis & Sons is the authorized sole distributor of Hurst Jaws of Life Equipment, which is used by the Fire Department to quickly and safely rescue community members trapped in vehicles due to serious traffic collisions; and

WHEREAS, in addition to providing this critical community safety equipment, this contract will also provide access to hoses, ladders, personal protective gear, heavy duty rescue equipment, urban search and rescue as well as hazardous materials response equipment; and

WHEREAS, The Purchasing Division of the Financial Management

1 Department researched procurement options for emergency response and firefighting
2 equipment and discovered other agencies had completed an open, fair, transparent, and
3 competitive procurement process. The City reviewed the cooperative agreement options
4 and determined that the contract between Sourcewell and L.N. Curtis & Sons provided the
5 best value to the City.

6 WHEREAS, Sourcewell has a Contract/Agreement etc. for the purchase of
7 these emergency response and firefighting equipment, Contract/Agreement etc. No.
8 040220-LNC (“Contract Number”); and

9 WHEREAS, the City’s participation in the Sourcewell Contract will facilitate
10 the City’s ability to purchase/furnish/etc. as well as provide considerable cost benefits to
11 the City; and

12 WHEREAS, if the City had to utilize a formal bid process rather than
13 participate in the Sourcewell Contract, considerably more funds would be required;

14 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
15 follows:

16 Section 1. The above recitals are true and correct and are incorporated
17 herein by this reference.

18 Section 2. The City Manager or designee is hereby authorized to enter an
19 agreement with L.N. Curtis & Sons to furnish and deliver emergency response and
20 firefighting equipment, of the same type and kind identified in the Sourcewell Contract
21 except as modified by mutual agreement of the City and L.N. Curtis & Sons, and the
22 purchase by the City shall be on the same terms and conditions afforded to Sourcewell in
23 an amount not to exceed Two Hundred Thousand Dollars (\$200,000), until the Sourcewell
24 contract expires on May 7, 2024, with the option to renew for as long as the Sourcewell
25 contract is in effect, at the discretion of the City Manager.

26 Section 3. This resolution shall take effect immediately upon its adoption
27 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
