1 FIRST AMENDMENT TO AGREEMENT NO. 33469

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33469 is made and
4 entered, in duplicate, as of January 22, 2016, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 February 4, 2014, by and between TOTUM CORP, a California corporation
7 ("Consultant"), with a place of business at 15130 Ventura Blvd., Suite 327, Sherman
8 Oaks, California 91403, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed project management services; and

12 WHEREAS, the parties entered Agreement No. 33469 whereby Consultant
13 agreed to provide these services; and

14 WHEREAS, the parties desire to extend the term;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
16 conditions herein contained, the parties agree as follows:

17 1. Section 2 of Agreement No. 33469 is hereby amended to read as
18 follows:

19 "2. TERM. The term of this Agreement shall commence at midnight on
20 February 5, 2014, and shall terminate at 11:59 p.m. on February 4, 2017, unless sooner
21 terminated as provided in this Agreement, or unless the services or the Project is
22 completed sooner. The parties have the option to extend this Agreement for one (1)
23 additional one (1) year term."

24 2. Except as expressly modified herein, all of the terms and conditions
25 contained in Agreement No. 33469 are ratified and confirmed and shall remain in full
26 force and effect.
