THIS FOURTH AMENDMENT TO AGREEMENT NO. 34369 is made and entered as of April 19, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 3, 2021, by and between MICHAEL BAKER INTERNATIONAL, INC., a Pennsylvania corporation (“Consultant”), with a place of business at 3760 Kilroy Airport Way, Suite 270, Long Beach, California 90806, and the CITY OF LONG BEACH, a municipal corporation (“City”).

WHEREAS, City and Consultant (the “Parties”) entered into Agreement No. 34369 (the “Agreement”) whereby Consultant agreed to provide as-needed public works construction management and inspection services in an amount not to exceed Five Hundred Thousand Dollars (\$500,000) with a three (3) year term, unless completed sooner, and two (2) extensions of one-year periods; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to August 31, 2020; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to August 31, 2021; and

WHEREAS, pursuant to a minute order at its meeting on August 3, 2021, the City Council of the City of Long Beach authorized an increase to the aggregate contracts’ amount and extensions to the agreements’ terms to August 31, 2022, for as-needed construction management and inspection services for public works projects, which included the Agreement;

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to August 31, 2022; and

WHEREAS, the Parties desire to increase the Agreement’s not to exceed amount by Two Hundred Thousand Dollars (\$200,000) for a total not to exceed amount of Seven Hundred Thousand Dollars (\$700,000);

NOW, THEREFORE, in consideration of the mutual terms, covenants, and

1 conditions herein contained, the Parties agree as follows:

2 1. Section 1.A. of the Agreement is hereby amended to read as follows:

3 "A. Consultant shall furnish specialized services more particularly
4 described in Exhibit "A", attached to the Agreement and incorporated by this
5 reference, in accordance with the standards of the profession, and City shall pay for
6 these services in the manner described below, not to exceed Seven Hundred
7 Thousand Dollars (\$700,000), at the rates or charges shown in Exhibit "B-1"."

8 2. Except as expressly modified herein, all of the terms and conditions
9 contained in Agreement No. 34369 are ratified and confirmed and shall remain in full force
10 and effect.
