3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AMENDING AND RESTATING THE  
5 SCHEDULE OF CIVIL PENALTIES AND ADMINISTRATIVE  
6 FEES FOR THE ENFORCEMENT OF VARIOUS PARKING  
7 VIOLATIONS  
8

9 WHEREAS, in 1992 the State Legislature amended the Vehicle Code to  
10 revise the procedures for the enforcement of violations of standing or parking offenses by  
11 generally providing that a violation of any unlawful standing or parking provision of law shall  
12 be subject to a civil penalty schedule established by the governing body of the jurisdiction  
13 in which the violation occurs and that the enforcement of the penalties shall be governed  
14 by a revised civil procedure including an administrative investigation and review procedure  
15 and an administrative and judicial appeal process; and

16 WHEREAS, California Vehicle Code Section 40203.5 provides that parking  
17 penalties shall be collected as civil penalties and that a schedule of parking penalties, late  
18 payment penalties, administrative fees and other related charges for parking violations  
19 shall be established by the governing body of the jurisdiction where the notice of violation  
20 is issued; and

21 WHEREAS, California Vehicle Code 40200.4(f) defines parking penalty to  
22 include but not be limited to any late payment penalty, administrative fee, assessment or  
23 cost of collection as provided by law in addition to the penalty direct violation of the  
24 applicable laws themselves; and

25 WHEREAS, the City Council, pursuant to Resolution No. C-26247, adopted  
26 September 16, 1997, established applicable civil penalties and related charges and  
27 administrative fees for violation of standing or parking offenses; and

28 WHEREAS, the City Council desires to further amend such penalties and

1 charges; and

2 WHEREAS, prior to the adoption of this resolution, public notice and hearing  
3 have been given in compliance with California Government Code Section 66018.

4 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
5 follows:

6 Section 1. The following civil penalties will be applicable to violations of the  
7 California Vehicle Code as listed below:


Sec. 4. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
