AMENDMENT TO THE CONTINUUM OF CARE GRANT AGREEMENT

This Amendment to Grant Agreement is made by and between the United States Department of Housing and Urban Development (HUD) and the City of Long Beach (the Recipient), of 1301 W. 12th Street, Long Beach, CA 90813.

RECITALS

1. HUD and the Recipient entered into a Grant Agreement dated September 22, 2020 having Grant No. CA9005U9D061900 (the Grant Agreement).
2. The parties are desirous of amending the Grant Agreement to delete eligible activities in particular to delete leasing because the provider has obtained a site without costs.
3. HUD has determined that the change is necessary to better serve eligible persons within the geographic area and to ensure that the priorities established under the most recent Notice Of Funding Availability are met.
4. The parties are desirous of amending the Grant Agreement to shift more than 10% from one eligible activity to another because leasing costs are no longer necessary.
5. HUD has determined that the change is necessary to better serve eligible persons within the geographic area and to ensure that the priorities established under the most recent Notice of Funding Availability are met.




