3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER OR DESIGNEE TO EXECUTE A CONTRACT
6 WITH QUALITY OFFICE FURNISHINGS, INC., FOR
7 FURNITURE AND RELATED ACCESSORIES, ON THE
8 SAME TERMS AND CONDITIONS AFFORDED TO THE
9 REGION 4 EDUCATION SERVICE CENTER THROUGH
10 THEIR CONTRACT WITH THE HON COMPANY LLC, AND
11 THE REGENTS OF THE UNIVERSITY OF CALIFORNIA
12 THROUGH THEIR CONTRACT WITH KIMBALL OFFICE,
13 INC., BOTH MADE AVAILABLE AS A COOPERATIVE
14 PURCHASING CONTRACT THROUGH OMNIA PARTNERS
15 PUBLIC SECTOR, IN AN AMOUNT OF \$105,535, WITH A
16 15% CONTINGENCY IN THE AMOUNT OF \$15,830, FOR A
17 TOTAL CONTRACT AMOUNT NOT TO EXCEED \$121,365,
18 UNTIL THE CONTRACTS EXPIRE, AT THE DISCRETION
19 OF THE CITY MANAGER

21 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the
22 City Manager to enter into a contract on behalf of the City, in writing or otherwise, without
23 advertising for bids, for services, supplies, materials, equipment or labor, with other
24 government agencies, when authorized by resolution; and

25 WHEREAS, on August 16, 2022, City Council authorized the Long Beach
26 Airport (Airport) to execute a new sublease for office space, necessitating the need for
27 additional office furniture components; and

28 WHEREAS, the Airport researched procurement options and identified other

1 agencies that had completed an open and competitive procurement process; and

2 WHEREAS, The Regents of the University of California on behalf of the
3 University of California, through Omnia Partners, Public Sector, has a contract with Kimball
4 Office, Inc. for office furniture and related services, Contract No. 2019.001896 (“Kimball
5 Contract”); and

6 WHEREAS, Region 4 Education Service Center, through Omnia Partners,
7 Public Sector, has a contract with The HON Company LLC for furniture, installation and
8 related services, Contract No. R191804 (“HON Contract”)

9 WHEREAS, Quality Office Furnishings, Inc. is the only authorized Dealer to
10 receive, deliver, install and reconfigure furniture through the Kimball and HON Contracts;
11 and

12 WHEREAS, the City’s participation in the Kimball and HON Contracts
13 (together “Omnia Contract”) will facilitate timely acquisition of the furniture and related
14 services as well as provide considerable cost benefits to the City; and

15 WHEREAS, if the City had to go to formal bid rather than participate in the
16 Omnia Contract considerably more funds would be required;

17 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
18 follows:

19 Section 1. The City Manager or designee is hereby authorized to enter an
20 agreement with Quality Office Furnishings, Inc. for furniture and related accessories and
21 services, of the same kind identified in the Omnia Contract in an amount of One Hundred
22 Five Thousand Five Hundred Thirty-Five Dollars (\$105,535), with a fifteen percent (15%)
23 contingency in the amount of Fifteen Thousand Eight Hundred Thirty Dollars (\$15,830), for
24 a total contract amount not to exceed One Hundred Twenty-One Thousand Three Hundred
25 Sixty-Five Dollars (\$121,365), until Region 4 Education Service Center Contract No.
26 R191804 expires on April 30, 2023, and The Regents of the University of California on
27 behalf of the University of California Contract No. 2019.001896 expires on April 30, 2024
28 with the option to renew for as long as the Omnia Contract is in effect, at the discretion of

1 the City Manager.

2 Section 2. This resolution shall take effect immediately upon its adoption
3 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

4 I hereby certify that the foregoing resolution was adopted by the City Council
