3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT AND ANY
6 NECESSARY AMENDMENTS THERETO WITH SIERRA-
7 CEDAR, INC. WITHOUT ADVERTISING FOR BIDS, FOR
8 COMPUTER AND CONSULTING SERVICES RELATED TO
9 THE ELECTRONIC PLAN CHECK SYSTEM IN AN
10 AMOUNT NOT TO EXCEED \$24,000

12 WHEREAS, on February 10, 2015, City Council authorized the selection of
13 e-Plan, Inc. as the City's preferred consultant to provide an Electronic Plan Check
14 System (the "System") to provide a convenient way for applicants and City staff to submit,
15 review and approve construction plan online; and

16 WHEREAS, as part of the System implementation, the Department of
17 Development Services requires an assessment to help identify configuration changes
18 needed to support integration between the System and existing land management
19 software; and

20 WHEREAS, three firms were approached for quotes related to this
21 assessment and Sierra-Cedar, Inc. was the only firm able to perform the work within the
22 requested timeframe; and

23 WHEREAS, as a result, no useful purpose would be served by advertising
24 for bids for computer and consulting services related to the Electronic Plan System and to
25 do so would constitute an idle and useless act and an unnecessary expenditure of public
26 funds because Sierra-Cedar, Inc. is the only corporation, firm or individual that could or
27 would bid for computer and consulting services related to the Electronic Plan System;

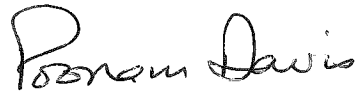
Section 2. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
