A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AND ANY NECESSARY AMENDMENTS THERETO WITH SIERRACEDAR, INC. WITHOUT ADVERTISING FOR BIDS, FOR COMPUTER AND CONSULTING SERVICES RELATED TO THE ELECTRONIC PLAN CHECK SYSTEM IN AN AMOUNT NOT TO EXCEED \$24,000

WHEREAS, on February 10, 2015, City Council authorized the selection of e-Plan, Inc. as the City's preferred consultant to provide an Electronic Plan Check System (the "System") to provide a convenient way for applicants and City staff to submit, review and approve construction plan online; and

WHEREAS, as part of the System implementation, the Department of Development Services requires an assessment to help identify configuration changes needed to support integration between the System and existing land management software; and

WHEREAS, three firms were approached for quotes related to this assessment and Sierra-Cedar, Inc. was the only firm able to perform the work within the requested timeframe; and

WHEREAS, as a result, no useful purpose would be served by advertising for bids for computer and consulting services related to the Electronic Plan System and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds because Sierra-Cedar, Inc. is the only corporation, firm or individual that could or would bid for computer and consulting services related to the Electronic Plan System;
