

1 THIRD AMENDMENT TO AGREEMENT NO. 34857

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 34857 is made and
4 entered, in duplicate, as of November 24, 2020, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on July
6 11, 2017, by and between KUBRA AMERICA WEST, INC., a California corporation
7 (“Consultant”), with a place of business at 14105 S. Normandie Avenue, Gardena,
8 California 90249, and the CITY OF LONG BEACH, a municipal corporation (“City”).

9 WHEREAS, City and Consultant (the “Parties”) entered into Agreement No.
10 34857 (the “Agreement”) whereby Consultant agreed to provided payment processing
11 services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to
13 provide for revised pricing for the Services; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement
15 to provide for revised pricing for the Services; and

16 WHEREAS, the Parties desire to extend the term of the Agreement one (1)
17 additional one-year period;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
19 conditions herein contained, the Parties agree as follows:

20 1. Section 2 of the Agreement is hereby amended to read as follows:

21 “2. TERM. The term of this Agreement shall commence at midnight on
22 December 4, 2017, and shall terminate at 11:59 p.m. on December 3, 2021, unless sooner
23 terminated as provided in this Agreement, or unless the services or the Project is
24 completed sooner. The term may be extended for one (1) additional one-year period, at
25 the discretion of the City Manager.”

26 2. Except as expressly modified herein, all of the terms and conditions
27 contained in Agreement No. 34857 are ratified and confirmed and shall remain in full force
28 and effect.




