A RESOLUTION OF THE OVERSIGHT BOARD OF THE CITY OF LONG BEACH AS THE SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF LONG BEACH APPROVING AN AMENDED REPAYMENT SCHEDULE FOR CERTAIN AGREEMENTS BETWEEN THE CITY OF LONG BEACH AND THE FORMER REDEVELOPMENT AGENCY OF THE CITY OF LONG BEACH

WHEREAS, the City of Long Beach loaned funds to the Redevelopment Agency of the City of Long Beach to carry out its redevelopment plans; and

WHEREAS, AB1x26 (the "Dissolution Act") voided loan agreements between cities and redevelopment agencies; and

WHEREAS, AB1484, legislation adopted to clean up earlier provisions of the Dissolution Act, provided that City-Agency loans could be deemed enforceable under certain circumstances: 1) a successor agency had received a finding of completion; 2) a successor agency had repaid the former redevelopment agency's debt to the Low- and Moderate-Income Housing Set-Aside Fund; and 3) a successor agency's oversight board made a finding that the city and agency loan agreements were for legitimate redevelopment purposes; and

WHEREAS, on April 26, 2013, the Successor Agency to the Redevelopment Agency of the City of Long Beach ("Successor Agency") received its finding of Completion; and

WHEREAS, on March 11, 2016, the California Department of Finance found that four loans were enforceable obligations; and

WHEREAS, in July 2016, the Successor Agency repaid the remaining debt

of the former Redevelopment Agency of the City of Long Beach to the Low- and Moderate - Income Housing Set-Aside Fund;

NOW, THEREFORE, the Oversight Board of the City of Long Beach as the Successor Agency to the Redevelopment Agency of the City of Long Beach resolves as follows:

Section 1. Approve the amended repayment schedule for certain agreements between the City of Long Beach and the former Redevelopment Agency of the City of Long Beach as more particularly described on Exhibit "A" attached hereto.

Section 2. This resolution shall take effect immediately upon its adoption by the Oversight Board, and the City Clerk shall certify the vote adopting this resolution.
