### THIRD AMENDMENT TO CONTRACT NO. 32932

# 

THIS THIRD AMENDMENT TO CONTRACT NO. 32932 is made and entered, in duplicate, as of August 27, 2014 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on August 19, 2014, by and between EXBON DEVELOPMENT, INC., a California corporation ("Contractor"), whose address is 131831 Newhope Street, Garden Grove, California 92843, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, pursuant to a "Notice Inviting Bids for Job Order Contract (JOC) in the City of Long Beach, California," dated February 2012, and published by City, bids were received, publicly opened and declared on the date specified in said Notice; and

WHEREAS, the parties entered into Contract No. 32932 for the work described in the bid documents; and

WHEREAS, the parties desire to extend the term and increase the Contract amount by \$2,850,000 to perform the demolition of the Belmont Pool and related temporary improvements;

NOW, THEREFORE, in consideration of the terms and conditions contained herein, the parties agree as follows:

1. Section 2.A. of Contract No. 32932 is hereby amended to read as follows:

# "2. PRICE AND PAYMENT.

A. City shall pay to Contractor the amount(s) for each Work Order based on the adjustment factor in Contractor's Bid, attached hereto as Exhibit "A"; provided, however, that City shall not pay more than Twelve Million Eight Hundred Fifty Thousand Dollars (\$12,850,000) for the term of the Contract, of which 1) \$7,000,000 is for use by the Port of Long Beach for tenant and security improvements at its Interim Headquarters Building, and 2) \$2,850,000 is used to perform the demolition of the

Belmont Pool and related temporary improvements."

2. Section 4.A. of Contract No. 32932 is hereby amended to read as follows:

## "4. TIME FOR CONTRACT.

A. The term of this Contract shall begin on December 1, 2012 and shall end on December 1, 2016 or on City's payment of the not-to exceed dollar amount hereunder to Contractor as specified in Section 2, whichever occurs first."

3. Except as expressly amended in this Third Amendment, all terms and conditions in Contract No. 32932 are ratified and confirmed and shall remain in full force and effect.
