ON CASE NO: 0701-06**

I am requesting the entire City Councils' concurrence in a "Motion to Rescind" the previous action taken April 3, 2007, on Item UB-36, regarding the application of Kelsang Youla and Khangtetsang Kelsang Namgyal, dba El Paisano Ranch Market, for an Original Alcoholic Beverage Control License, at 245 West Pacific Coast Highway.

The original item was voted on while the Sixth District City Council seat was vacant. Upon my inspection of the business, I have found a very clean family owned business, owners that consist of a father, mother, a son, and two sisters. The owners have a reputation of giving back to the community with donations to community organizations such as the Wrigley Association and NAG. Also, attached is a petition signed by 340 of the markets neighbors and customers supporting the application for Original Alcoholic Beverage Control License.

Suggested Action: I respectfully request that the Long Beach City Council rescind the previous action taken April 3, 2007, Item UB-36, Case No: 0701-06, regarding the application of Kelsang Youla and Khangtetsang Kelsang Namgyal, dba El Paisano Ranch Market, for an Original Alcoholic Beverage Control License, at 245 West Pacific Coast Highway.

In addition, I request to receive and file an Original Alcoholic Beverage Control License application, with conditions, of Kelsang Youla and Khangtetsang Kelsang Namgyal, dba El Paisano Ranch Market, at 245 West Pacific Coast Highway.

PROPOSED CONDITIONS

El Paisano Ranch Market
245 West Pacific Coast Highway
Long Beach, CA 90806

1. No person under the age of 21 shall sell or package alcoholic beverages.
2. There shall be no coin operated games or video machines maintained upon the premises at any time.
3. A single jukebox or stereo may be maintained upon the premises; however, the music shall not be audible outside the premises.
4. The petitioner shall be responsible for maintaining free of litter the area adjacent to the premises over which he or she has control.
5. No alcoholic beverages shall be consumed on any property adjacent to the licensed premises under the control of this licensee.
6. The parking lot of the premises shall be equipped with lighting of sufficient power to illuminate and make easily discernible the appearance and conduct of all persons on or about the parking lot. Additionally, the position of such lighting shall not disturb the normal privacy and use of any neighboring residences.
7. No pay phone will be maintained on the exterior of the premises.
8. Petitioner shall regularly police the area under his or her control in an effort to prevent the loitering of personas about the premises.
9. Any graffiti painted or marked upon the premises or on any adjacent area under the control of the licensee shall be removed or painted over within 24 hours of being applied.
10. Sale, service and consumption of alcoholic beverages shall be permitted only between the hours of 9:00 am-9:00pm Sunday through Thursday and 9:00am-11:00pm Friday and Saturday.
11. There shall be no sale of "fortified" wine at any time.
12. No individual plastic cups will be sold at any time.
13. There shall be no amplified music on the premises at any time.
14. Beer, malt beverages, and wine coolers in containers of 16 oz. or less cannot be sold by single containers, but must be sold in manufacturer pre-packaged multi-unit quantities.

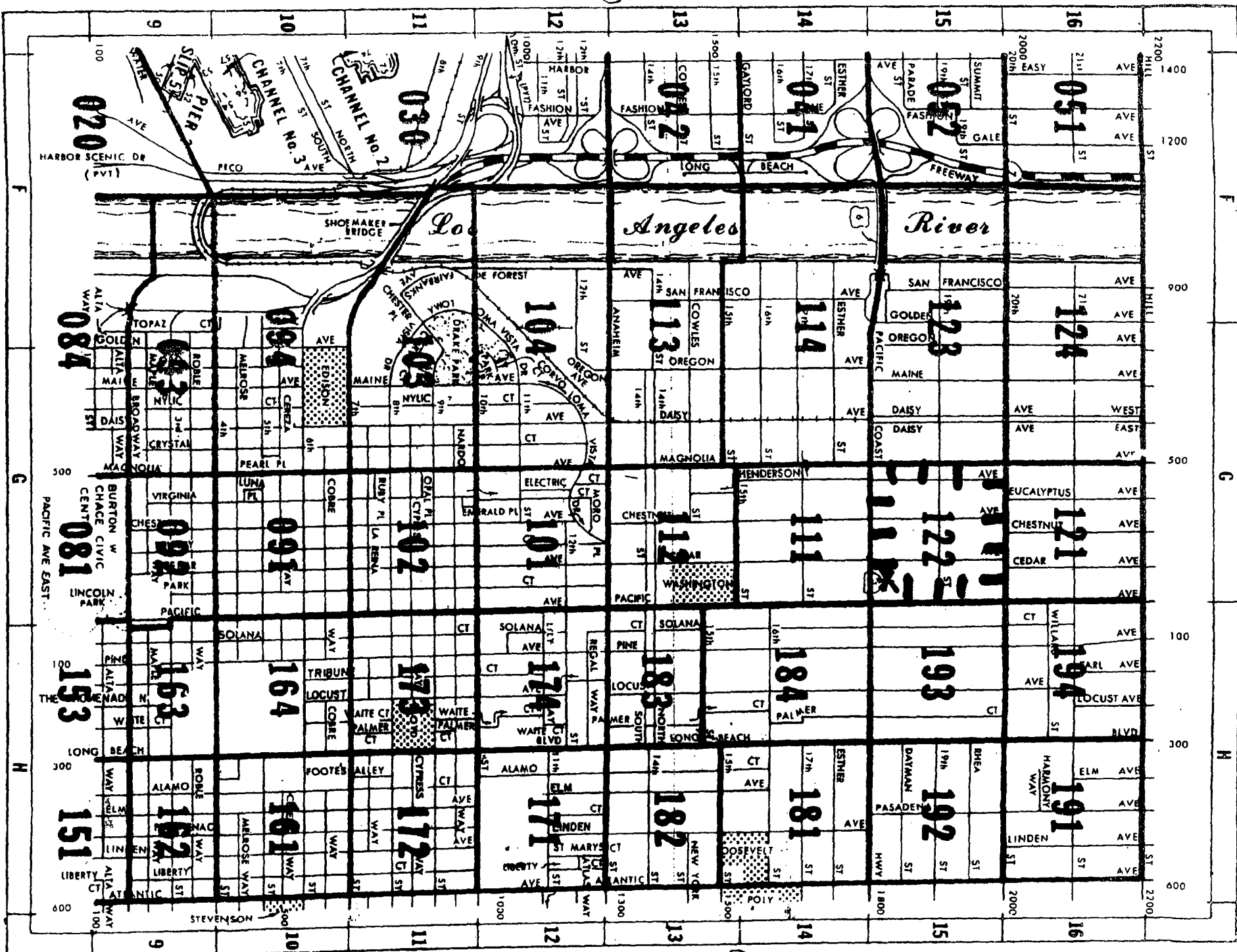

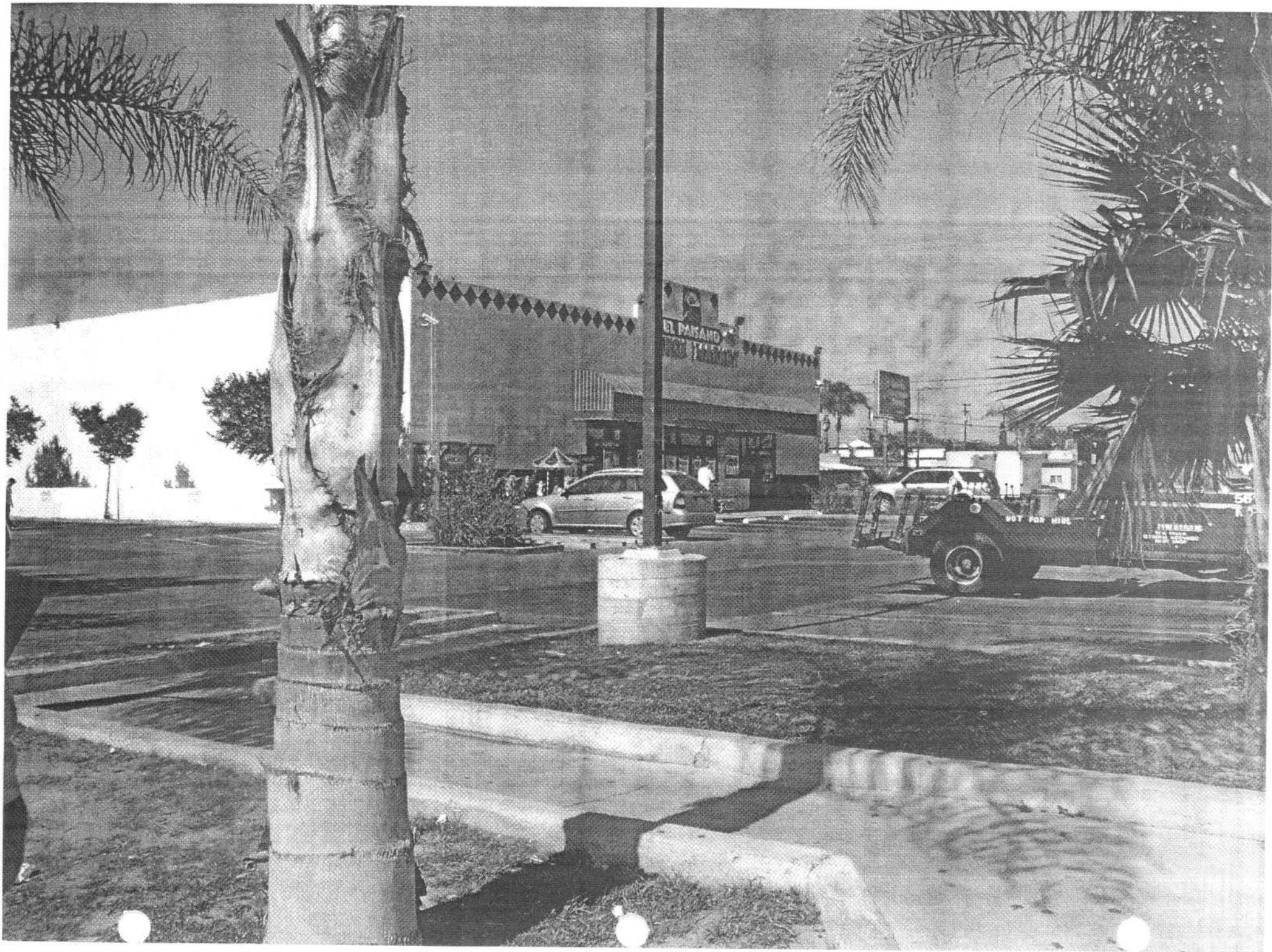

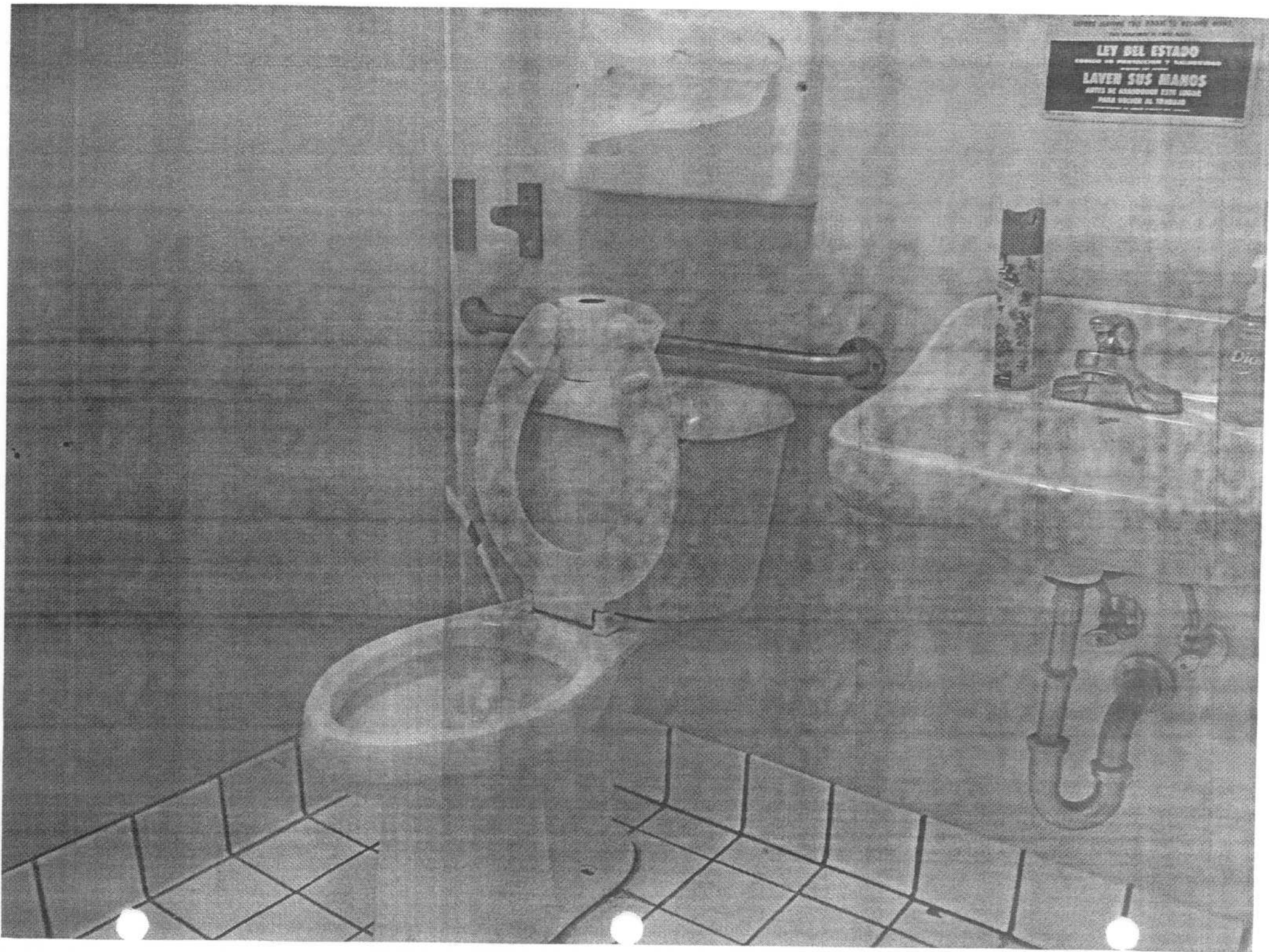
