FIRST AMENDMENT TO AGREEMENT NO. 28336

THIS FIRST AMENDMENT TO AGREEMENT NO. 28336 is made and entered, in duplicate, as of November 27, 2002 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 26, 2002, by and between THE GORDIAN GROUP, doing business in California as THE MELLON GROUP, a ^{Georgia Dym 202} Delaware corporation ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 28336 whereby Consultant agreed to provide specialized services requiring unique skills to be performed in connection with the development and design of a program for Job Order Contracting ("JOC"); and

WHEREAS, the parties desire to extend the term of the Agreement accordingly;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and herein, the parties agree as follows:

1. Section 2 of Agreement No. 28336 is hereby amended in its entirety to read as follows:

"2. TERM. The initial term of this Agreement shall commence at midnight on February 1, 2003, and shall terminate at 11:59 p.m. on January 31, 2005. The extended term of this Agreement shall commence at midnight on February 1, 2005 and, unless sooner terminated as provided herein, shall terminate at 11:59 p.m. on January 31, 2006, or unless the services to be performed hereunder or the Project is completed sooner. City shall have the option to extend the term of this Agreement for an additional period of one (1) year."

3. Except as expressly amended herein, all terms and conditions in Agreement No. 28336 are ratified and confirmed and shall remain in full force and effect.
