## SECOND AMENDMENT TO AGREEMENT NO. 35522

## 

THIS SECOND AMENDMENT TO AGREEMENT NO. 35522 is made and entered, in duplicate, as of January 21, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 14, 2020, by and between SUPREME TOWING SERVICE, INC., DBA CITY TOW SERVICE, a California corporation ("Contractor"), with a place of business at 1485 Canal Ave., Long Beach, CA 90813, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35522 (the "Agreement") whereby Contractor agreed to provide as-needed vehicle towing ("Project"); and

WHEREAS, the parties entered into a First Amendment to revise the annual amount of the Agreement; and

WHEREAS, the parties currently desire to enter into a Second Amendment to increase the annual amount of the agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 1.A. of Agreement No. 35522 is hereby amended to read as follows:
  - "A. Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an annual amount not to exceed Two Hundred Fifty-Seven Thousand Four Hundred Forty-Eight Dollars (\$257,448), for a period of two years, with the option to renew for three additional one-year periods, at the rates or charges shown in Exhibit "B". Contractor is not entitled to any money under this Agreement unless the City, in its sole discretion,

requests Contractor to provide services pursuant to this Agreement."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35522 are ratified and confirmed and shall remain in full force and effect.
