3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34126 is made and  
4 entered, in duplicate, as of October 9, 2018 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 October 20, 2015, by and between ARCADIS U.S., INC., a Delaware corporation  
7 ("Consultant"), with a place of business at 320 Commerce, Suite 200, Irvine, California  
8 92602, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
10 34126 whereby Consultant agreed to provide the specialized services as described in  
11 Request for Qualifications AP13-030; and

12 WHEREAS, the Parties desire to extend the term one (1) additional one-year  
13 period and attach an updated rate schedule;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
15 conditions herein contained, the Parties agree as follows:

16 1. Section 2 of Agreement No. 34126 is hereby amended to read as  
17 follows:

18 "2. TERM. The term of this Agreement shall commence at midnight on  
19 December 1, 2015, and shall terminate at 11:59 p.m. on November 30, 2019, unless  
20 sooner terminated as provided in this Agreement, or unless the services or the Project is  
21 completed sooner. The term can be extended for one (1) additional one-year period,  
22 exercisable upon advance written notice from City to Consultant."

23 2. The Rates contained in Exhibit "B-1" to this Amendment hereby  
24 replace and supersede the rates attached to Agreement No. 34126. Exhibit "B-1" to this  
25 Amendment is hereby incorporated into the Agreement as a replacement to Exhibit "B".
