

1 FIRST AMENDMENT TO AGREEMENT NO. 30770

3 THIS FIRST AMENDMENT is made and entered, in duplicate, as of May 1,
4 2009 for reference purposes only, pursuant to a minute order adopted by the City Council
5 of the City of Long Beach at its meeting held on June 17, 2008, by and between
6 MOFFATT & NICHOL, a California corporation, with a place of business at 3780 Kilroy
7 Airport Way, Suite 600, Long Beach, California 90806 ("Consultant"), and the CITY OF
8 LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City required specialized services requiring unique skills to
10 be performed in connection with the Reconnaissance Study of the Long Beach
11 Breakwater in the City of Long Beach ("Project"); and

12 WHEREAS, City and Consultant entered into Agreement No. 30770 on
13 August 1, 2008, and

14 WHEREAS, the parties now desire to extend the term of the Agreement for
15 an additional period of three months;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions in this Agreement, the parties agree as follows:

18 1. Section 2 of Agreement No. 30770 is amended and deleted in its
19 entirety to read as follows:

20 "2. TERM: The term of this Agreement shall commence on August 1,
21 2008, and shall terminate on July 31, 2009, unless sooner terminated as
22 provided in this Agreement, or unless the services to be performed
23 hereunder or the Project are completed sooner."

24 Except as expressly amended herein, all of the terms and conditions in
25 Agreement No. 30770 are ratified and confirmed and shall remain in full force and effect.
