RECOMMENDATION:

Recommendation to authorize the City Attorney to submit Stipulations with Request for Award for approval by the Workers' Compensation Appeals Board, and if so approved, authority to pay \$143,296.25 for Stipulations with Request for Award with a life pension thereafter of \$123.69 per week thereafter, subject to cost-of-living increases, in compliance with the Appeals Board Order for Manuel Lopez.

DISCUSSION:

Manuel Lopez has made a claim for injuries allegedly sustained in the course of his employment with the City of Long Beach. The Economic Development and Finance Committee, on April 5, 2011, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Manuel Lopez based upon a 76 percent disability rating, with provision for a life pension at the rate of \$123.69 per week thereafter, subject to cost-of-living increases, with the provision for lifetime medical care as may be necessary.

DISCUSSION:


