FIRST AMENDMENT TO AGREEMENT NO. 30009

1
2 This First Amendment to Agreement No. 30009 ("Amendment") is made
3 and entered, in duplicate, pursuant to a minute order adopted by the City Council of the
4 City of Long Beach on March 6, 2007, by and between the CITY OF LONG BEACH, a
5 municipal corporation ("City") and DINTER ENGINEERING COMPANY, a Nevada
6 corporation ("Consultant").

7 WHEREAS, City and Consultant previously entered into an Agreement
8 dated March 6, 2007 (the "Agreement"), pursuant to which Consultant agreed to perform
9 certain mechanical, electrical and plumbing services for City; and

10 WHEREAS, City and Consultant now desire to amend the Agreement to,
11 among other things, reflect a mutual exercise of the first option to extend the term of the
12 Agreement;

13 NOW, THEREFORE, City and Consultant mutually agree as follows:

14 1. This Amendment shall be effective as of the date on which this
15 Amendment is executed by both parties (the "Effective Date").

16 2. City payment for services described in the Agreement shall not
17 exceed \$3,000,000.00 over the term of the Agreement, as extended by this Amendment.

18 3. Pursuant to the exercise of the mutual option to extend the term
19 under Section 2 of the Agreement, the term of the Agreement shall be extended for three
20 (3) years, and shall expire on December 31, 2012. City and Consultant have one (1)
21 remaining three-year option under Section 2 of the Agreement.

22 4. Exhibit "B" to the Agreement is hereby amended so that the City's
23 Representative is Mario Rodriguez, Director, Long Beach Airport, or designee.

24 5. All terms, covenants, and conditions of the Agreement, except as
25 amended herein, shall remain unchanged and in full force and effect.




