SECOND AMENDMENT TO AGREEMENT NO. 35903
35903

THIS SECOND AMENDMENT TO AGREEMENT NO. 35903 is made and entered, in duplicate, as of April 4, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 13, 2021, by and between INTELINET INCORPORATED, a California corporation ("Consultant"), with a place of business at 9106 Pulsar Court, Unit H, Corona, California 92883, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35903 (the "Agreement") whereby Consultant agreed to provide as-needed Citywide data, telephone, and fiber optic structured cabling; and

WHEREAS, the Parties entered into a First Amendment to increase the contract for a total not to exceed amount of \$1,300,000; and

WHEREAS, the Parties desire to reduce the annual amount to \$1,000,000 and extend the term one (1) additional one-year-period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an annual amount not to exceed Eight Hundred Thousand Dollars (\$800,000) for the term May 1, 2021 through April 30, 2023; and an annual amount of One Million Three Hundred Thousand (\$1,300,000) for the term June 24, 2022 through April 30, 2023; and an annual amount of One Million Dollars (\$1,000,000) for the term May 1, 2023 through April 30, 2024, at the rates or charges shown in Exhibit "B"."

2. Section 2. of the Agreement shall commence at midnight on May 1,

1 2021, and shall terminate at 11:59 p.m. on April 30, 2024, unless sooner terminated as
2 provided in this Agreement, or unless the services or the Project is completed sooner. The
3 term may be extended for two (2) additional one-year periods, at the discretion of the City
4 Manager.”


5 3. Except as expressly modified herein, all of the terms and conditions
6 contained in Agreement No. 35903 are ratified and confirmed and shall remain in full force
7 and effect.

9 executed with all formalities required by law as of the date first stated above.




