### CONTRACT CHANGE ORDER AUTHORIZATION NO. 5

In accordance with procedures for changes in the work as established in the specifications, you are authorized to do the following:

1.	Provide all labor, materials and equipment to saw cut and demo existing Portland Concrete Cement pavement (PCC) bike path, at the negotiated unit cost of \$1.35 per square foot (1,020/SF @ \$1.35/SF), as directed by the Project Engineer,
	for the estimated cost of\$ 1,377.00
2.	Provide all labor, materials and equipment to grade and compact subgrade to 90% for temporary pedestrian bike path, at the negotiated unit cost of \$.45 per square foot (6,500/SF @ \$.45/SF), as directed by the Project Engineer,
	for the estimated cost of\$ 2,925.00
3.	Provide all labor, materials and equipment to install 2x2"-inch wood edger for the temporary pedestrian bike path, at the negotiated unit cost of \$5.20 per lineal foot (590/LF @ \$5.20/LF), as directed by the Project Engineer,
	for the estimated cost of\$ 3,068.00
4.	Provide all labor, materials and equipment for the placement of 3"-inch thick of asphalt concrete pavement for the temporary pedestrian bike path, at the negotiated unit cost of \$3.40 per square foot (1500/SF @ \$3.40/SF), as directed by the Project Engineer,
	for the estimated cost of\$ 5,100.00
5.	Provide all labor, materials and equipment to install pedestrian walking direction signs for the temporary pedestrian bike path, at the negotiated unit cost of \$300.00 each (3/EA @ \$300/EA), as directed by the Project Engineer,
	for the estimated cost of\$ 900.00

TOTAL ESTIMATED INCREASE TO THE CONTRACT COST .......\$ 13,370.00



By signing this change order the Contractor acknowledges that it is familiar with California Civil Code Section 1542, which reads: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor;" and Contractor hereby releases the City from any unknown claims and waives its rights under Section 1542.

The prices set forth herein above shall be considered full compensation for all obligations of the contractor associated with claim of the contractor for delays or extra compensation resulting from performance of the requirements of this change order.
