3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY TO
5 EXECUTE AN AGREEMENT TO PURCHASE
6 TELECOMMUNICATIONS EQUIPMENT AND SERVICES
7 THROUGH THE CONTRACTS BETWEEN AT&T GLOBAL
8 SERVICES AND THE STATE OF CALIFORNIA

10 WHEREAS, the Charter of the City of Long Beach, Section 1802, permits
11 the City to participate in joint cooperative purchasing of services, supplies, materials,
12 equipment, and labor with other government agencies by purchasing under their contracts
13 on a voluntary and selective basis when authorized by resolution; and

14 WHEREAS, the City of Long Beach desires to purchase
15 telecommunications equipment and services from AT&T Global Services; and

16 WHEREAS, the State of California ("State") has a contract for the purchase
17 of AT&T Global Services known as Price Agreement Nos. 5-06-58-20 (DTS06E1390)
18 AND 5-06-58-21 (DTS 06E1391) ("Price Contracts"); and

19 WHEREAS, City's participation in the Price Contracts will facilitate
20 acquisition of telecommunications equipment and services as well as provide
21 considerable cost benefits to the City; and

22 WHEREAS, if the City had to go to formal bid rather than participate in the
23 Price Contracts considerably more funds would be required;

24 NOW, THEREFORE, the City of Long Beach resolves as follows:

25 Section 1. The above recitals are true and correct and are incorporated
26 herein by this reference.

27 Section 2. The City Manager of the City of Long Beach is hereby
28 authorized to enter an agreement with AT&T Global Services for the purchase of

1 telecommunications equipment and services as ordered by the City of Long Beach,
2 pursuant to the Price Contracts. The purchase by the City of Long Beach shall be on the
3 same terms and conditions afforded to the State, in an amount not to exceed \$95,000.00
4 annually.

5 Section 3. This resolution shall take effect immediately on its adoption by
6 the City Council, and the City Clerk shall certify the vote adopting this resolution.

7 I hereby certify that the foregoing resolution was adopted by the City
