SECOND AMENDMENT TO LICENSE TO USE CITY-OWNED PARKING AREA

THIS SECOND AMENDMENT TO LICENSE NO. 30019 is made and entered, in duplicate, as of December 21, 2010 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 18, 2006, by and between CONTE PRODUCTIONS, a California corporation ("Licensee") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered License No. 30019, whereby the City granted Licensee a two (2) year license to use the Marina Parking Area for the sole purpose of conducting an arts and crafts market for the sale of arts and crafts items, and for no other purpose; and

WHEREAS, the parties exercised the first option to renew the license for an additional term of two (2) years on May 8, 2009; and

WHEREAS, the parties now desire to exercise the remaining two (2) year option to extend the term for an additional two (2) years;

NOW, THEREFORE, in consideration of the mutual terms and conditions in License No. 30019, the parties agree as follows:

- 1. Section Three (3) of License No. 30019 is deleted and amended in its entirety to read as follows:
 - "3. <u>Term, Termination and Extension</u>. The term of the license is hereby extended so that the license will remain in effect through January 31, 2013. Either party may terminate this License by giving at least thirty (30) days prior notice to the other party."
- 2. Except as expressly amended herein, all of the terms and conditions of License No. 30019 as amended, are ratified and confirmed and shall remain in full force and effect.
