4th AMENDMENT TO AGREEMENT

AGREEMENT NO. 29046

THIS AMENDMENT to AGREEMENT is made this 10th day of May, 2006, between **CITY OF LONG BEACH**, called the **Contractor**, and the **LONG BEACH UNIFIED SCHOOL DISTRICT**, hereinafter called the **District**.

WITNESSETH

The Contractor and District do mutually agree as follows:

1. To amend that certain Agreement 1869.01 entered into on January 10, 2005, to administer 21st Century WRAP after-school programs at Edison, Garfield, Grant and Lafayette schools due to increased California Department of Education (CDE) grant funding:
 - A. By increasing the core contract amount by ONE HUNDRED SIXTY SIX THOUSAND SEVEN HUNDRED THIRTY FOUR AND NO/100 DOLLARS (\$166,734.00) (Edison-\$49,884.00, Garfield-\$50,426.00, Grant-\$24,158.00, Lafayette-\$42,266.00) FROM NINE HUNDRED NINETY SIX THOUSAND THREE HUNDRED TWENTY TWO AND NO/100 DOLLARS (\$996,322.00) for a total contract amount of ONE MILLION ONE HUNDRED SIXTY THREE THOUSAND FIFTY SIX AND NO/100 DOLLARS (\$1,163,056.00); and
 - B. By extending the contract completion date from June 30, 2006 to be through December 31, 2006.
 - C. By adding the following condition:

Work shall be performed in accordance with the 21st Century Policies and Procedures Manual that has been issued by the District, incorporated herein by reference.
2. Except as amended herein, the terms and conditions of Agreement 1869.01 effective May 1, 2004, shall remain in full force and effect.
