1 FIRST AMENDMENT TO AGREEMENT NO. 28258

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 28258 is made and
4 entered, in duplicate, as of November 3, 2005 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 1, 2005, by and between RBF CONSULTING, ~~INC.~~^{RBF}, a California corporation
7 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

8 WHEREAS, the parties entered Agreement No. 28258 whereby Consultant
9 agreed to provide specialized services in connection with As-Needed Architectural &
10 Engineering Design ("Project"); and

11 WHEREAS, the parties desire to extend the term of the Agreement;

12 NOW, THEREFORE, in consideration of the mutual terms and conditions in
13 Agreement No. 28258 and herein, the parties agree as follows:

14 1. Section 1(A) of Agreement No. 28258 is hereby amended to read as
15 follows:

16 "1. SCOPE OF WORK OR SERVICES. A. Consultant shall furnish
17 specialized services more particularly set forth in Exhibit 'A', attached hereto and
18 incorporated herein by this reference, in accordance with the standards of the profession,
19 and City shall pay for said services an amount not to exceed \$1,350,000.00."

20 2. Section 2 of Agreement No. 28258 is hereby amended in its entirety
21 to read as follows:

22 "2. TERM. The initial term of this Agreement shall commence at midnight
23 on March 25, 2003, and shall terminate at 11:59 p.m. on March 24, 2006. The extended
24 term of this Agreement shall commence at midnight on March 25, 2006 and, unless sooner
25 terminated as provided in this Agreement, or unless the services to be performed
26 hereunder or the Project is completed sooner, shall terminate at 11:59 p.m. on March
27 24, 2007."

28 3. Except as expressly amended herein, all terms and conditions in

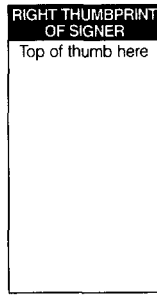
