HONORABLE MAYOR AND CITY COUNCIL City of Long Beach California

RECOMMENDATION:

Adopt a Resolution of Intention to vacate Pasadena Avenue between 33rd Street and Interstate 405 San Diego Freeway; set the date of May 15, 2018, for the public hearing on the vacation; and,

Accept Categorical Exemption CE-17-020. (District 7)

DISCUSSION

SA Properties Company L.P., owner of the commercial property at 530 East 33rd Street and the vacant lot on the southwest corner of Pasadena Avenue and 33rd Street (Applicant), requested the vacation of the portion of Pasadena Avenue between 33rd Street and Interstate 405 (I-405) San Diego Freeway (Attachment A – Vacation Sketch). This portion of Pasadena Avenue divides two lots that are owned by the Applicant. This segment of Pasadena Avenue provides access only to the adjacent commercial properties directly to the west and east. The property directly west is improved as a surface parking lot and the property directly east is developed with a commercial building, which is currently vacant. Vacating this portion of Pasadena Avenue would allow the Applicant to merge these lots.

Proceedings for this vacation are being conducted in accordance with Chapter 3, General Vacation Procedure, of the Public Streets, Highways and Service Easements Vacation Law of the California Streets and Highways Code. Findings must establish that the subject right-of-way is unnecessary for present or prospective public use. The Public Works Department supports this vacation based on findings that the portion of Pasadena Avenue between 33rd Street and I-405 Freeway to lots owned by the Applicant are not necessary as a vehicular or pedestrian thoroughfares.

On May 18, 2017, the Planning Commission determined that the proposed vacation of the 10,110-square-foot area was in conformance with the adopted goals of the City's General Plan and approved Categorical Exemption CE-17-020 (Attachment B – Planning Commission Staff Report). In conformance with the California Environmental Quality Act, Categorical Exemption CE-17-020 was adopted for this development (Attachment C – Notice of Exemption).

The necessary departments, including Traffic Engineering, Fire and Police have reviewed the proposed right-of-way vacation and have no objections to this action. Conditions of approval, satisfying the concerns of the public utility companies are attached (Attachment D - Conditions).

A public hearing on this matter is to be held on May 15, 2018, and will allow all persons interested in, or objecting to, the proposed vacation to appear and be heard. At that time, the City Council will deliberate and take action on the proposed vacation.

This matter was reviewed by Deputy City Attorney Linda T. Vu on March 21, 2018 and by Budget Analysis Officer Julissa José-Murray on March 20, 2018.

TIMING CONSIDERATIONS

City Council action is requested on April 17, 2018, to set a public hearing date on this matter for May 15, 2018.

FISCAL IMPACT

A tentative vacation processing fee of \$10,105 was deposited in the General Fund (GF) in the Public Works Department (PW). There is no local job impact associated with this recommendation.

RESOLUTION NO.

A RESOLUTION OF INTENTION TO VACATE PASADENA AVENUE BETWEEN 33RD STREET AND INTERSTATE 405 SAN DIEGO FREEWAY, IN THE CITY OF LONG BEACH, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, PURSUANT TO THE PUBLIC STREET, HIGHWAYS AND SERVICE EASEMENTS LAW (DIVISION 9, PART 3, CALIFORNIA STREETS AND HIGHWAYS CODE); FIXING A TIME AND PLACE FOR HEARING ALL PERSONS INTERESTED IN OR OBJECTING TO THE PROPOSED VACATION

The City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach hereby elects to proceed under Division 9, Part 3, Chapter 3, of the California Streets and Highways Code (Section 8320 *et seq.*), as amended, generally known and referred as the "Public Street, Highways and Service Easements Law", and hereby declares its intention to vacate Pasadena Avenue between 33rd Street and Interstate 405 San Diego Freeway, in the City of Long Beach, County of Los Angeles, State of California, described more particularly as follows:

"That portion of Pasadena Avenue lying south of the south line of 33rd Street, as said street is shown on Tract No. 2901, and lying northerly of the northwesterly prolongation of the southwesterly line of Parcels 2 and northerly and easterly of the northerly and easterly lines of Parcels 3, as said parcels are described in the Director's Deed recorded May 13, 1965 as Instrument No. 3101, of Official Records of Los Angeles County, as more particularly described hereinafter and as shown on Exhibit "B" attached

That portion of Pasadena Avenue lying south of the southerly right of way line of 33rd Street (formerly Crest Drive) 60 feet wide, as shown on Tract No. 2901, in the City of Long Beach, County of Los Angeles, State of California, recorded in Book 36, page 63 of Maps, in the office of the County Recorder of said County, and lying northerly and easterly of the following described line:

Beginning at a point on the easterly line of Lot 10, in Block "E" of said Tract No. 2901, distant North 00°05'53" West 30.00 feet along said easterly line of said Lot 10 from the southeast corner thereof; Thence South 00°05'53" East along said easterly line of said Lot 10 a distance of 3.16 feet to the TRUE POINT OF BEGINNING of the herein described line; Thence from said True Point of Beginning South 56°54'55" West a distance of 13.17 feet to the beginning of a tangent curve concave easterly and having a radius of 46.00 feet; Thence westerly, southerly, and easterly along said curve through a central angle of 126°36'45", an arc distance of 101.65 feet to a point; A radial of said curve to said last mentioned point bears South 20°18'10" West; Thence easterly, non-tangent to said curve, in a direct line, to a point in the easterly line of Lot 11, in Block "E" of said Tract No. 2901, being the point of terminus of the line described herein, distant northerly thereon 1.00 foot from the intersection of the easterly line of said Lot 11 with the northwesterly prolongation of the following described line.

Beginning at the southeast corner of Lot 3, in Block "F" of said Tract No. 2901; Thence northwesterly in a direct line to a point in the westerly line of said Lot 3, distant southerly thereon 19.43 feet from the northwesterly corner of said Lot 3.

Excepting therefrom that portion thereof lying within the boundary lines of parcel 1 as described in a grant deed to the State of California,

recorded on December 03, 1958, as Instrument No. 1809, of Official Records of Los Angeles County described as follows:

That portion of Lot 10 in Block "E" of Tract 2901, as per map recorded in Book 36, page 63 of Maps, in the office of the County Recorder of said County, described as follows:

Beginning at the southeast corner of said Lot; Thence along the easterly line of said Lot, Northerly 30.00 feet; Thence in a direct line, Southwesterly to a point on the southerly line of said Lot, distant Westerly 35.00 feet from the said southeast corner; Thence along said southerly line, Easterly to the point of beginning.

Reserving therefrom an easement for public utility purposes over the above described parcel of land.

The above described parcel of land contains 10,110 square feet, more or less. Subject to all matters of record, if any.

Reserving unto the City of Long Beach, its successors and assigns a perpetual easement and right-of-way, at any time or from time to time, to lay, construct, maintain, operate, repair, renew, replace, change the size of and remove the existing utility lines, including, but not limited to, sanitary sewers, storm drains and appurtenant structures, together with all necessary gates, valves, fittings, hydrants and appurtenances for the transportation of water and gas, with the right of ingress to and egress from the same, over, through, under, along and across that certain property vacated herewith; and pursuant to any existing franchises or renewals thereof, or otherwise, to construct, maintain, operate, replace, remove, renew and enlarge lines of conduits, cables, wires, poles and other convenient structures, equipment and fixtures for the operation of telephone lines and other communication lines, and for the transportation or distribution of electric energy, and incidental purposes including access and

the right to keep the property free from inflammable materials, and wood growth, and otherwise protect the same from all hazards in, upon and over the part vacated. Access for maintenance of the above-mentioned facilities must be maintained at all times. No improvements shall be constructed within the easement which would impede the operation, maintenance or repair of said facilities. Construction of any improvements, including changes of grade, shall be subject to the prior written approval of all the City departments and public utilities responsible for the above said facilities."

Section 2. All of the foregoing real property is shown on the map or plan thereof, attached hereto as Exhibit "A", and on file in the office of the City Clerk, which map or plan is known and referred to as "City of Long Beach Department of Public Works Vacation Sketch No. 1023V".

2018 The City Council hereby fixes Section 3. at the hour of 5:00 p.m., as the time and the City Council Chamber, Plaza Level of the City Hall, 333 West Ocean Boulevard, in the City of Long Beach, California, as the place for hearing all persons interested in or objecting to the proposed vacation.

The City Council hereby directs that notice of said hearing on Section 4. this proposed street vacation be published for at least two (2) successive weeks prior to the hearing and in the manner provided by Section 8322 of the State Streets and Highways Code.

The City Council hereby directs that notice of this street Section 5. vacation be posted conspicuously along the street proposed to be vacated at least two (2) weeks before the date set for hearing and in the manner provided by Section 8323 of the State Streets and Highways Code.


Section 6. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify to the vote adopting this resolution.



RECOMMENDATION:

Accept Categorical Exemption CE-17-020 and find the proposed vacation of a segment of Pasadena Avenue, south of 33rd Street and north of the San Diego Freeway (I-405), in conformance with goals and policies of the City's General Plan. (District 7)

APPLICANT:

SA Properties - William Russell

116A Main Street

Tiburon, California 94920 (Application 1701-36)

DISCUSSION

The request is for a General Plan conformity determination associated with a vacation of a 150-foot segment of Pasadena Avenue located between East 33rd Street and the I-405 Freeway (Exhibit A – Location Map and Exhibit B – Street Plan).

Pasadena Avenue generally extends north and south through the City and the General Plan Mobility Element classifies it as a local street. This segment of Pasadena Avenue is improved as a cul-de-sac which terminates at the I-405 Freeway. This segment of Pasadena Avenue provides access only to the adjacent commercial properties, directly west and east. The property directly west is improved as a surface parking lot and the property directly east is developed with a commercial building which is currently vacant. The street vacation will facilitate a lot merger of the two commercial properties for a potential future development.

This portion of Pasadena Avenue is located in the Community Automobile-Oriented (CCA) zoning district and the Land Use District - Moderate Density Residential District (LUD 3B) on the General Plan Land Use Map.

General Plan Consistency Findings

Before an application for street vacation can be considered by the City Council, a finding of conformity with the maps and policies of the Long Beach General Plan must be made by the Planning Commission. The General Plan consists of 11 elements and each element carries the same authority concerning land use issues. All elements of

the General Plan were considered and staff finds the requested street vacation to be in conformance with all applicable elements. The Land Use Element divides the City into 21 land use districts, which provide general guldance as to the appropriate type and density of land uses. This portion of Pasadena Avenue is located within Land Use District Number 3B – Moderate Density Residential District (LUD 3B) which encourages apartment and condominium living opportunities in moderate density projects. As part of the 2040 Land Use Element update, land use districts will be replaced with *Placetypes*. The proposed Placetype for this area is Neighborhood-Serving Center or Corridor – Moderate (NSC-M). The NSC-M Placetype is characterized by medium-rise moderate intensity mixed use (housing and retail) commercial centers and corridors that provide goods and services conveniently located relative to housing. Commercial uses would be consistent with both the proposed land use Placetype and the current CCA zoning district. Vacation of this segment of Pasadena Avenue would revert the land and control to the property owner of the two adjacent properties.

The City's Mobility Element is aimed at transforming Long Beach into a community that offers flexible, convenient, affordable, and energy-efficient transportation options for residents and visitors alike. This segment of Pasadena Avenue is developed as a culde-sac that terminates at the I-405 Freeway. The Department of Public Works regards this cul-de-dac as no longer necessary for present or prospective public use or convenience. This segment of Pasadena Avenue currently provides access only to the two adjacent commercial properties. Other north-south streets providing vehicular and pedestrian access are located one block west and east of Pasadena Avenue. The abandonment of this portion of Pasadena Avenue would not prove detrimental to the movement of people and goods through the area.

ENVIRONMENTAL REVIEW

In accordance with the guidelines for implementing the California Environmental Quality Act (CEQA), Categorical Exemption CE-17-020 was issued for the proposed request (Exhibit C – Categorical Exemption).





CONDITIONS OF APPROVAL

SKETCH NO. 1023V

The following conditions of approval for the vacation of Pasadena Avenue between 33rd Street and Interstate 405 San Diego Freeway is conditioned on the Developer/Vacation Petitioner:

- 1. An easement for utility purposes shall be reserved on Pasadena Avenue. No building may be constructed within the easement area.
- 2. All street and alley curb returns that are no longer functional for the vacated street or alley shall be improved with full height curb and curb gutters.
- 3. Sidewalk improvements in the project area shall be completed using new Portland Cement Concrete.
- 4. Vacation Petitioner shall become responsible for maintaining the vacated property immediately after City Council approval.
- 5. All publicly-owned street lights within the vacated pubic right of way must be returned to City Light and Power or purchased by the vacation petitioner. The power supply circuits to these street lights must be modified as necessary in order to make the applicant responsible for paying the cost of lighting, to the satisfaction of the Director of Public Works.
- 6. Any required traffic control modifications (i.e. traffic signage, curb, street stripping, and etcetera) are the responsibility of the vacation petitioner, and shall be installed in the public right of way under a street improvement permit from the Department of Public Works.
- 7. The vacation petitioner shall at its own cost resolve any storm water drainage problems resulting from the vacation to the satisfaction of the Director of Public Works.
- 8. The intersections of 33rd Street and Pasadena Avenue shall be reconstructed to eliminate the appearance of a public street.
- 9. An easement shall be reserved for utility purposes. No buildings may be constructed within the vacated portion of the street.

Attachment D Page 1 of 2 10. The vacation petitioner shall resolve all problems regarding the abandoned oil pipeline.

The above conditions are flexible in that they may be adjusted in consideration of changing conditions or if new information is discovered prior to the adoption of the resolution ordering the vacation by the City Council. These conditions are in addition to the requirements of the City of Long Beach Planning Commission's and must be completed at the expense of the vacation petitioner and to the satisfaction of the Director of Public Works.
