

1 FIRST AMENDMENT TO AGREEMENT NO. 34661

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34661 is made and
4 entered, in duplicate, as of May 14, 2019, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on June 13,
6 2017, by and between RDC-S111, INC. DBA STUDIO 111, a California corporation
7 ("Consultant"), with a place of business at 245 E. Third Street, Long Beach, California
8 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 34661 (the "Agreement") whereby Consultant agreed to provide as needed urban planning
11 design services; and

12 WHEREAS, the Parties desire to extend the term one (1) additional one-year
13 period and add \$200,000;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions herein contained, the Parties agree as follows:

16 1. Section 1.A. of the Agreement is hereby amended to read as follows:

17 "A. Consultant shall furnish specialized services more particularly
18 described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
19 accordance with the standards of the profession, and City shall pay for these services in
20 the manner described below, not to exceed Eight Hundred Thousand Dollars (\$800,000),
21 at the rates or charges shown in Exhibit "B"."

22 2. Section 2 of the Agreement is hereby amended to read as follows:

23 "2. TERM. The term of this Agreement shall commence at midnight on
24 July 1, 2017, and shall terminate at 11:59 p.m. on June 30, 2020, unless sooner terminated
25 as provided in this Agreement, or unless the services or the Project is completed sooner.
26 The Parties have the option to extend the term for two (2) additional one-year periods at
27 the discretion of the City Manager."

28 3. Except as expressly modified herein, all of the terms and conditions
