3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34160 is made and  
4 entered, in duplicate, as of September 19, 2017, for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 June 20, 2017, by and between MARYAM A. ABDELNABY, M.D., INC., a California  
7 corporation ("Contractor"), with a place of business at 2563 Plaza Del Amo #406,  
8 Torrance, California 90503, and the CITY OF LONG BEACH, a municipal corporation  
9 ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be  
11 performed in connection with Jail Inmate Medical Services ("Project"); and

12 WHEREAS, the parties entered Agreement No. 34160 whereby Contractor  
13 agreed to provide these services; and

14 WHEREAS, the parties desire to extend the Contract term;

15 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
16 conditions herein contained, the parties agree as follows:

17 1. Section 2. Of Agreement No. 34160 is hereby amended to read as  
18 follows:

19 "2. TERM. The term of this Agreement shall commence at  
20 midnight on September 1, 2015, and shall terminate at 11:59 p.m. on  
21 September 1, 2018, unless sooner terminated as provided in this  
22 Agreement, or unless the services or the Project is completed sooner. The  
23 parties have the option to extend the term for one (1) additional one-year  
24 period."

25 2. Except as expressly modified herein, all of the terms and conditions  
26 contained in Agreement No. 34160 are ratified and confirmed and shall remain in full  
27 force and effect.
