RESOLUTION NO. RES-23-0019

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH TO TEMPORARILY CLOSE AND REMOVE FROM PUBLIC USE CERTAIN STREETS, ALLEYS, WALKWAYS, THE PROMENADE AND DOWNTOWN SHORELINE BIKE PATH IN THE CITY OF LONG BEACH IN CONNECTION WITH THE CONDUCT OF THE 2023 GRAND PRIX OF LONG BEACH

The City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach finds and determines that the conduct of the 2023 Grand Prix of Long Beach on the streets of the City of Long Beach and the coverage thereof by the media provides a unique opportunity for the City of Long Beach to publicize and call attention to the City, its natural advantage, resources, enterprises, attractions, climate and facilities.

Section 2. For the conduct of the 2023 Grand Prix of Long Beach, the following streets will hereby have temporary lane reductions for the periods stated:

A. From February 27, 2023 at 9:00 a.m. to May 3, 2023 at 11:59 p.m., Shoreline Drive westbound from Ocean Boulevard to Long Beach Arena service road (reduce existing three lanes to two lanes).

B. From February 23, 2023 at 7:00 a.m. to April 30, 2023 at 11:59 p.m., Shoreline Drive eastbound from Linden Avenue to Ocean Boulevard (reduce existing three lanes to two lanes).

C. From March 2, 2023 at 7:00 a.m. to April 27, 2023 at 11:59 p.m., Seaside Way from Pine Avenue to Linden Avenue (reduce existing two lanes to one lane in each direction, with placement of temporary stop signs

1 at Seaside Way/Locust Avenue, Seaside Way/Collins Way, Seaside
2 Way/Hart Place and Seaside Way/Linden Avenue. Intersection signage to
3 be placed by City).

4 D. From March 6, 2023 at 7:00 a.m. to April 21, 2023 at 11:59
5 p.m., Pine Avenue from Ocean Boulevard south to Upper Esplanade (reduce
6 existing five lanes to three lanes).

7 Section 3. For the conduct of the 2023 Grand Prix of Long Beach, the
8 following streets, alleys, promenade, walkways, and bike path are hereby temporarily
9 closed for the periods stated:

10 A. On April 14, 2023 from 7:00 a.m. to 5:00 p.m., Shoreline Drive
11 eastbound from Broadway off-ramp to Ocean Boulevard, Shoreline Village
12 Drive to Shoreline Drive eastbound and westbound, Shoreline Drive
13 westbound from Ocean Boulevard to Chestnut Place northbound.

14 B. On April 14, 2023 from 4:00 a.m. to 5:00 p.m., Golden Shore
15 on-ramp to Shoreline Drive eastbound, Chestnut Place northbound and
16 southbound from Seaside Way to Queensway Bridge, Seaside Way from
17 Pine Avenue to eastern end of Seaside Way, Aquarium Way from Shoreline
18 Drive to Chestnut Avenue, Hart Place from Seaside Way to Ocean
19 Boulevard, Collins Way from Seaside Way to Ocean Boulevard, Cedar
20 Avenue at Shoreline Drive, Linden Avenue from Ocean Boulevard to
21 Shoreline Drive, Bay Street at Pine Avenue and The Paseo at Pine Avenue.

22 C. On April 14, 2023 from 9:45 a.m. to 10:15 a.m., 10:45 a.m. to
23 11:15 a.m., 1:15 p.m. to 1:45 p.m., and 2:15 p.m. to 2:45 p.m., Pine Avenue
24 from Ocean Boulevard to Upper Esplanade, Linden Avenue from Ocean
25 Boulevard to Shoreline Drive, Seaside Way from Linden Avenue to Marina
26 Way (eastern end).

27 D. From April 12, 2023 at 5:00 a.m. to April 17, 2023 at 5:00 p.m.,
28 Seaside Way from Pine Avenue to eastern end of Seaside Way, Linden

1 Avenue from Ocean Boulevard to Seaside Way, Marine Way from Locust
2 Avenue to Collins Way, Atlantic Way from Ocean Boulevard to Seaside Way,
3 Marine Way from Hart Place to eastern end, Linden Avenue, northbound and
4 southbound from Shoreline Drive to Marina Parking lot, Locust Avenue from
5 Ocean Boulevard to Seaside Way, Cedar Avenue at Shoreline Drive, Bay
6 Street at Pine Avenue, The Paseo at Pine Avenue and Aquarium Way from
7 Shoreline Drive to Chestnut Avenue.

8 E. From April 12, 2023 at 7:00 a.m. to April 17, 2023 at 5:00 p.m.,
9 Shoreline Drive westbound from Ocean Boulevard and Alamitos intersection
10 to 3rd Street on-ramp northbound, Chestnut Avenue southbound and
11 northbound from Seaside Way to Queensway Bridge, Aquarium Way from
12 Shoreline Drive to Chestnut Place, and Cedar Avenue at Shoreline Drive.

13 F. From April 12, 2023 at 7:00 a.m. to April 17, 2023 at 5:00 p.m.,
14 Shoreline Drive eastbound from Broadway off-ramp to Ocean Boulevard and
15 Alamitos intersection, Golden Shore on-ramp to Shoreline Drive eastbound,
16 Shoreline Village Drive from Marina Parking lot to Shoreline Drive.

17 G. On April 14, 15, and 16, 2023 from 6:00 a.m. to 7:00 p.m., Pine
18 Avenue from Ocean Boulevard to Upper Esplanade.

19 H. On April 14, 15, and 16, 2023 from 6:00 a.m. to 7:00 p.m.,
20 Promenade South from Seaside Way to Shoreline Drive Terminus.

21 I. On April 14, 15, and 16, 2023 from 6:00 a.m. to 7:00 p.m.,
22 walkway off of Seaside Way from Hart Place to the east end of Seaside Way.

23 J. From April 12, 2023 at 7:00 a.m. to April 17, 2023 at 11:59 p.m.,
24 the Bike Path beginning at Seaside Way and Chestnut Avenue east to a point
25 approximately four hundred feet (400') east of the permanent concession
26 stand behind the Villa Riviera.

27 K. From February 27, 2023 through April 21, 2023, Shoreline
28 Drive from Ocean Boulevard to Shoreline Village Drive, Aquarium Way

1 between Shoreline Drive and Chestnut Place, and Pine Avenue between
2 Seaside Way and Shoreline Drive, intermittently at the discretion of the City
3 Manager, or his designee, in order to allow for pedestrian bridge placement
4 and removal, but only during the hours from 10:00 p.m. to 8:00 a.m.

5 Section 4. The temporary closing of the above streets, alleys, walkways,
6 promenade and bike path for the times herein provided is necessary for the safety and
7 protection of the participants and spectators in the 2023 Grand Prix of Long Beach and
8 qualifying events to be held from April 14, 2023 through April 16, 2023, utilizing the streets
9 described herein.

10 Section 5. For the period of 4:00 a.m. to 5:00 p.m. on April 4, 2023, the
11 streets and alleys described in Sections 3.A. through 3.C. are hereby withdrawn and
12 removed from public use.

13 Section 6. For the period April 12, 2023 at 5:00 a.m. to April 17, 2023 at
14 5:00 p.m., the streets and alleys described in Section 3.D. are hereby withdrawn and
15 removed from public use.

16 Section 7. For the period April 12, 2023 at 7:00 a.m. to April 17, 2023 at
17 5:00 p.m., the streets and alleys described in Section 3.E. are hereby withdrawn and
18 removed from public use.

19 Section 8. For the period April 12, 2023 at 3:00 p.m. to April 17, 2023 at
20 5:00 p.m., the streets and alleys described in Section 3.F. are hereby withdrawn and
21 removed from public use.

22 Section 9. On April 14, 15, and 16, 2023 from 6:00 a.m. to 7:00 p.m., the
23 streets, promenade and alleys described in Sections 3.G. through Section 3.I. are hereby
24 withdrawn and removed from public use.

25 Section 10. For the period April 12, 2023 at 6:00 a.m. to April 17, 2023 at
26 11:59 p.m., the bike path described in Section 3.J. is hereby withdrawn and removed from
27 public use.

28 Section 11. From February 27, 2023 through April 21, 2023, the streets and

1 alleys described in Section 3.K. are hereby intermittently withdrawn and removed from
2 public use at the discretion of the City Manager, or his designee, in order to allow for
3 pedestrian bridge placement and removal.

4 Section 12. The City Manager, or his designee, is authorized and directed
5 to post notices of the intent to temporarily reduce lanes, close the streets, alleys, walkways
6 and portions of the promenade described in Sections 2, 3, 4, 5, 6, 7, 8, 9, 10 and 11 above
7 at least twenty-four (24) hours prior to the closure thereof.

8 Section 13. This resolution shall take effect immediately upon its adoption
9 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
