3 THIS SECOND AMENDMENT TO AGREEMENT NO. 31416 is made and
4 entered, in duplicate, as of September 20, 2011 for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 3, 2009, by and between VAN SCOYOC ASSOCIATES, INC., a Washington,
7 D.C. corporation ("Consultant"), with a principle place of business at 101 Constitution
8 Avenue, NW, Suite 600 Washington, D.C. 20001, and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, it is essential that City establish and maintain effective liaison
11 with agencies and officials of federal, state and local governments and other bodies,
12 commissions, committees and organizations; and

13 WHEREAS, City desires to present pertinent information, facts and data to
14 said agencies and officials relating to matters involving and affecting City and its
15 interests; and

16 WHEREAS, City requires information and data from agencies and officials
17 of the federal and state governments and other entities in order to facilitate the operation
18 of the government of City; and

19 WHEREAS, representation of City's interests and liaison between City and
20 other officials, agencies, bodies, commissions, committees and organizations require the
21 assistance of personnel experienced in such matters; and

22 WHEREAS, the parties entered Agreement No. 31416 whereby Consultant
23 agreed to provide such services; and

24 WHEREAS, the parties desire to extend the term of the Agreement:

25 NOW, THEREFORE, in consideration of the mutual terms and conditions
26 contained in Agreement No. 31416 and herein, the parties agree as follows:
