WHEREAS, City and Contractor (the "Parties") entered into Contract No. 33970 (the "Contract") pursuant to Specifications No. G-331 for the Annual Contract for Steel Gas Pipeline Construction in the City of Long Beach; and

WHEREAS, the Parties entered into a First Amendment to the Contract to extend the term to August 31, 2018 and attach an updated price list; and

WHEREAS, the Parties entered into a Second Amendment to the Contract to extend the term to August 31, 2019 and attach an updated price list; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and add the annual amount of \$5,500,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions herein contained, the Parties agree as follows:

- 1. Section 4.A of the Contract is hereby amended to read as follows:
- "A. The term of this Contract shall commence at midnight on September 1, 2015, and shall terminate at 11:59 p.m. on August 31, 2020, unless sooner terminated as provided in this Contract, or unless the services or the Project is completed sooner."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Contract No. 33970 are ratified and confirmed and shall remain in full force and effect.
