1 FIRST AMENDMENT TO AGREEMENT NO. 33322

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33322 is made and  
4 entered, in duplicate, as of May 5, 2015 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 October 1, 2013, by and between the NATIONAL COUNCIL FOR COMMUNITY  
7 DEVELOPMENT, INC., a New York not-for-profit corporation dba The National  
8 Development Council ("Consultant") and the CITY OF LONG BEACH, a municipal  
9 corporation ("City").

10 WHEREAS, the parties entered into Agreement No. 33322 (the  
11 "Agreement") whereby Consultant agreed to provide consulting services in connection  
12 with various commercial redevelopment projects; and

13 WHEREAS, the parties wish to exercise their option to extend the term of  
14 the Agreement; and

15 WHEREAS, the parties agree that the total compensation for the extended  
16 term shall not exceed \$46,000.00 per year;

17 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
18 the Agreement and in this First Amendment, the parties agree as follows:

19 1. Section 4 of Agreement No. 33322 is hereby amended to read as  
20 follows:

21 "4. Term. The term of this Agreement shall commence at midnight on  
22 October , 2013, and shall terminate at 11:59 p.m. on September 30, 2017, unless sooner  
23 terminated as provided in this Agreement, or unless the services or the Project is  
24 completed sooner."

25 2. Except as expressly modified herein, all of the terms and conditions  
26 contained in Agreement No. 33322 are ratified and confirmed and shall remain in full  
27 force and effect.
