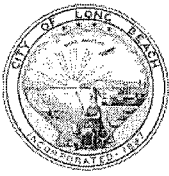

I request that the City of Long Beach impose the following conditions for Garfield Beach CVS LLC, dba CVS Pharmacy 9505, which is located at 4400 East Los Coyotes Diagonal:

1. Sales of alcoholic beverages shall take place only between the hours of 8:00 a.m.- midnight Monday through Sunday.
2. All beverages offered for sale at the premises shall be displayed and available for convenient inspection and purchase within the premises by the general public.
3. Petitioner(s) shall regularly police the area under their control in an effort to prevent loitering and sleeping of persons about the general premises.
4. Full compliance with conditions as set by the Planning Commission in the final Conditional Use Permit.
