## FIRST AMENDMENT TO MASTER SERVICES AGREEMENT NO. 34848

THIS FIRST AMENDMENT TO AGREEMENT NO. 34848 is made and entered, in duplicate, as of December 9, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 17, 2017, by and between ARCADIS U.S., INC, a Delaware corporation ("Arcadis"), with a place of business at 630 Plaza Drive, Suite 100, Highlands Ranch, CO 80129, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Arcadis (the "Parties") entered into Agreement No. 34848 (the "Agreement") whereby Arcadis agreed to provide services in connection with the provision of Orion Project Portfolio Management ("Orion PPM") Software; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- Section 6 of the Agreement is hereby amended to read as follows: 1.
- "6. TERM. The term of this Agreement shall commence at midnight on December 1, 2017, and shall terminate at 11:59 p.m. on November 30, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The parties have the option to extend the term one (1) additional oneyear period, at the discretion of the City Manager."
- Except as expressly modified herein, all of the terms and conditions 2. contained in Agreement No. 34848 are ratified and confirmed and shall remain in full force and effect.
