3 THIS FIRST AMENDMENT TO CONTRACT NO. 30235 (this
4 "Amendment") is made and entered, in duplicate, as of July 1, 2012, for reference
5 purposes only, pursuant to a minute order adopted by the City Council of the City of Long
6 Beach ("Agency") at its meeting on September 4, 2007, by and between ARINC
7 Incorporated ("ARINC"), and the CITY OF LONG BEACH, a municipal corporation
8 ("Customer").

9 WHEREAS, ARINC and Customer entered into a Service Agreement dated
10 September 1, 2007 (the "Contract") whereby ARINC agreed to provide certain software,
11 hardware and maintenance services at the Long Beach Airport; and

12 WHEREAS, the parties desire to increase the authorize amount that may
13 be expended by Customer under the Contract in connection with the expiration of the
14 term of the Contract and the completion of ARINC's services thereunder.

15 NOW, THEREFORE, in consideration of the mutual terms and conditions in
16 the Contract, the parties agree as follows:

17 1. The Contract is amended so that the maximum authorized amount to
18 be paid by Customer to ARINC for services performed in connection with the Contract is
19 up to One Million Five Hundred Eighty-Eight Thousand Three Hundred Thirty-Seven and
20 No/100 Dollars (\$1,588,337).

21 2. Except as expressly amended herein, all of the terms and conditions
22 of the Contract are ratified and confirmed and shall remain in full force and effect.
